What we are doing

From 17 February to 31 March 2024, we will be carrying out works south of the Chiltern Railways between Harvil Road and Breakspear Road South, within our site boundaries, as shown on the map overleaf.

These activities will include excavation works and the removal of the abutment wall located near the Chiltern Railways. The wall will be removed in sections.

How this work might affect you

Due to the proximity to the Chiltern Railway Line, and for safety reasons, these works will need to be carried out at night when trains are not running.

We would like to apologise in advance for any disruption or inconvenience these works may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way.

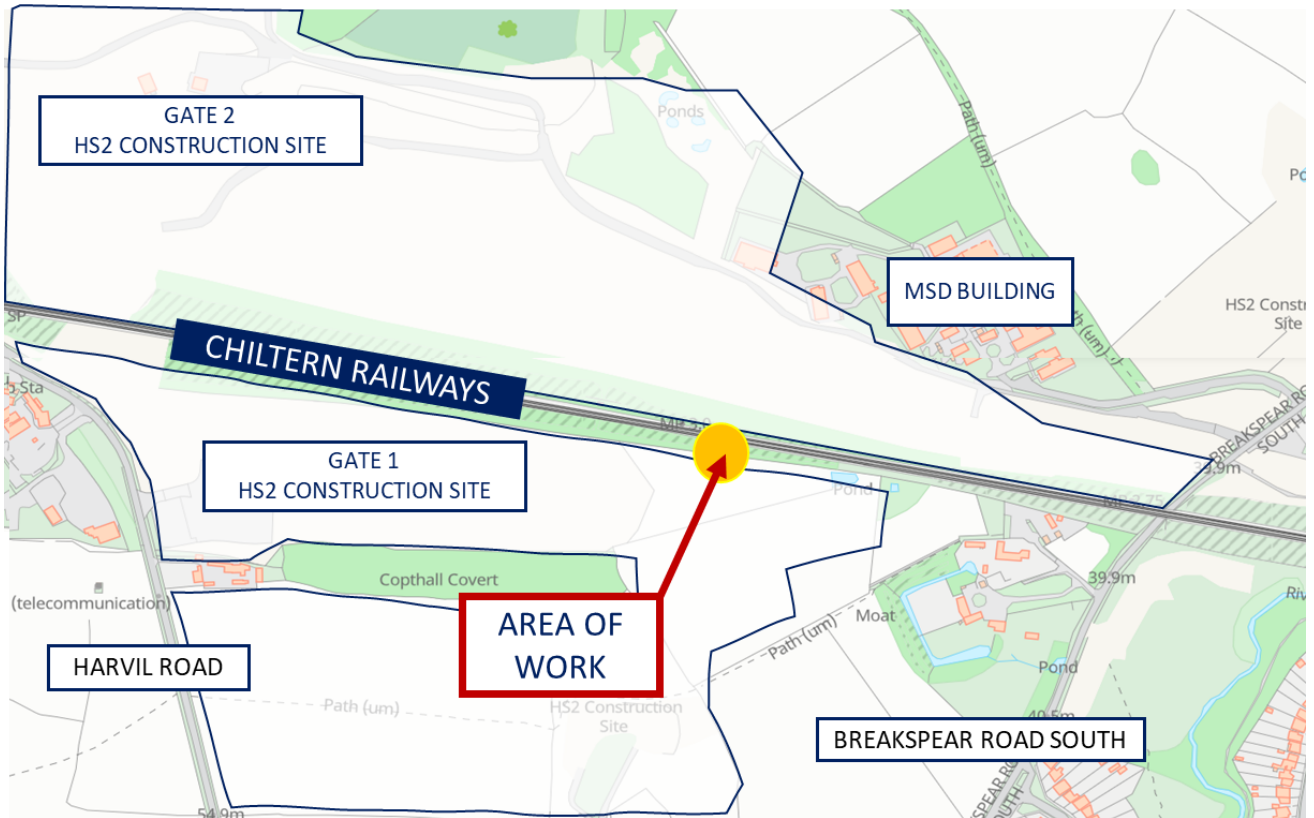
