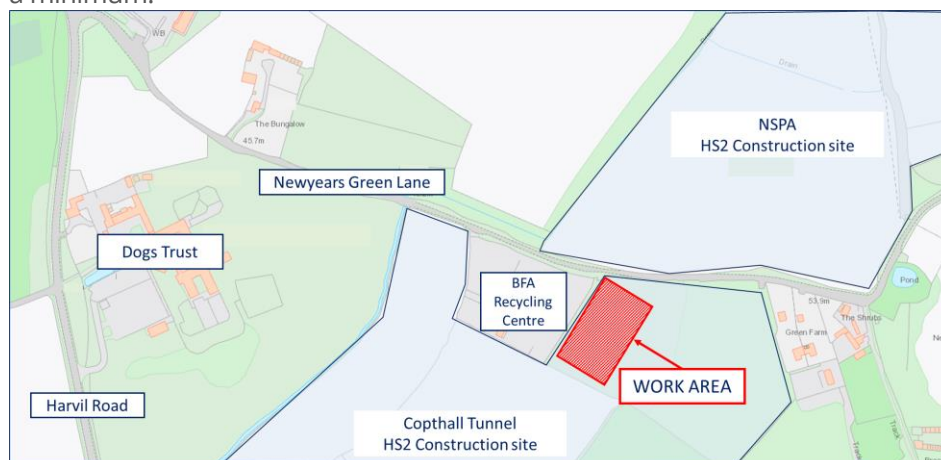

What we are doing

From 4 to 16 March 2024, we will be breaking out concrete to remove the conveyor ramp, south of Newyears Green Lane within our Copthall tunnel site boundary.

The removal of the concrete foundations will enable the demobilisation of the conveyor system over Newyears Green Lane. It will also clear the area in preparation for the removal of the conveyor bridge, planned for May 2024. The location of the work is shown on the map below.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.
