



Update: Works on West Gate

High Speed Two (HS2) is the new high speed railway for Britain.

West Gate Gas Diversion

From 6 February to 2 March 2024, these works will take place overnight on West Gate between 7pm and 5am.

These works will be followed by the next phase of works due to start on **4 March until 30 March 2024**, between 8am and 8pm.

As works to strengthen and protect the gas mains ahead of future tunnelling works continue, you can view the previous notifications on the HS2 in your area map via the HS2 in Brent and Ealing webpage.

How will this affect you

We will create temporary changes on West Gate to ensure the safety of the public and our staff.

From **6 February to 30 March 2024**, there will be traffic management in place. This will include a footpath closure, lane closures and parking bay suspensions. Maps are included on the following page.

We will use noise reducing barriers where possible to help minimise any noise in the local community, working as efficiently as possible whilst keeping our work areas safe and tidy.
