



Single lane closure on B4118 Birmingham Road for improvement works

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

What works, when and what will this involve

We will be operating temporary two-way traffic lights along the B4118 Birmingham Road, Water Orton, from Monday 26 February 2024 until Friday 1 March 2024. The traffic lights will be operational during off-peak hours only (9.30am – 3.30pm). We need to use the traffic lights to carry out improvement works on the road.

We will be re-modelling the road and installing street lighting, cabinets for telecommunications equipment, digital signage and other street furniture.

To complete this, we will be using a vacuum excavator which uses compressed air to loosen or agitate the ground. We then remove the loosened material under the vacuum as the machine creates a hole.

To minimise disruption on the road network, we will divide our works in phases so that once a phase is complete we will move on to the next. Please see the location plan overleaf.

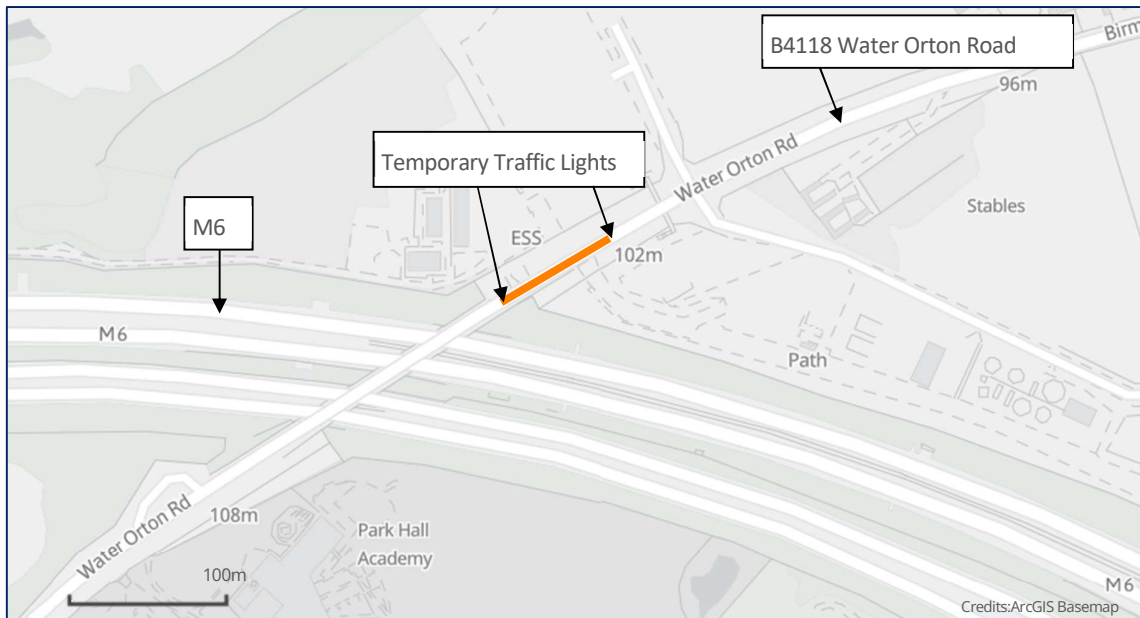

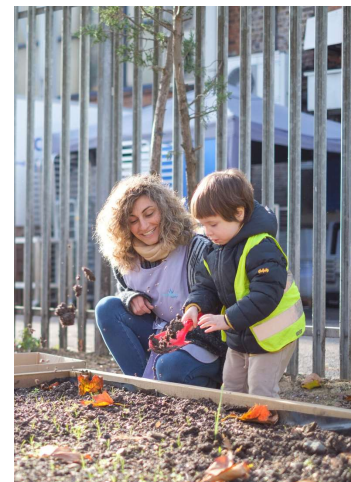
About our Community and Business Funds
