## Road closure on Chesham Lane, Chalfont St Peter, for removal of survey equipment

High Speed Two (HS2) is the new high speed railway for Britain. This notice is to update you on a temporary road closure on Chesham Lane in Chalfont St Peter. This is to undertake the removal of monitoring equipment used for our tunnelling works.

### How will these works affect you?

A small section of Chesham Lane will be temporarily closed to traffic on the following dates:

- 19 and 20 February 2024

### What about residents and pedestrians?

Residential access will be maintained, and the footpath will remain open to pedestrians.

### What will we be doing?

A small team of operatives will be visible in the highway whilst removing the monitoring equipment. To do this safely, a small section of Chesham Lane will be temporarily closed. Once completed the traffic management will be removed.

Please see the location map of these works on page 2. The diversion will be via Gorelands Lane, Vache Lane and London Road.

- Small section of Chesham Lane closed in both directions
- Fully signed diversion route via Joiners Lane, London Road A413, Vache Lane, and Gorelands Lane
- Operatives visible and working in the area

### What we will do

- Keep you updated with known changes
- Inform local Parish Councils, village associations and residents
- Reopen the road as soon as possible

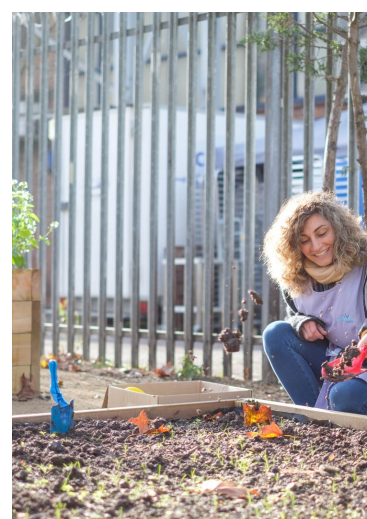
## About our Community and Business Funds
