High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Common Lane Concrete Pour

We previously notified you that we will be working 24 hours a day to facilitate concrete pours across our Birmingham sites and that these dates would become available at short notice. We now know that we will be carrying out an early morning concrete pour at Common Lane on Monday 26 February. This activity is necessary to facilitate the Curzon Street deck installation. We understand that this may cause some inconvenience, and we apologise in advance for any disturbance caused.

What to expect

During this time, you may notice our operatives accessing the Common Lane gates between 11.30 pm and 1am. This is to allow sufficient time for the teams to prepare for the batching plant activity. You may also hear some noise as we prepare to start works but this will be monitored continuously to ensure we are reducing our impact on neighbours.

Concrete Pour starting on Monday 26 February 2024

1 night -1.00am – 8.00am

Our workforce can be on site up to 1 hour before work begins to set up the site and again afterwards to take down our work equipment.
