High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### Our works

We will be creating a temporary diversion on Watling Street, to allow for future construction works, and to enable Watling Street to pass over the new railway.

To enable the safe and efficient delivery of these works, we require closures of Watling Street.

Our works include resurfacing, connecting the existing road to the temporary diversion and line painting.

### When the work will take place

These works will take place as follows:

Temporary traffic lights on Watling Street

- 18 March until 29 March 24 hrs (Including weekend)

Full closure of Watling Street

- 2 April until 7 April 24hrs

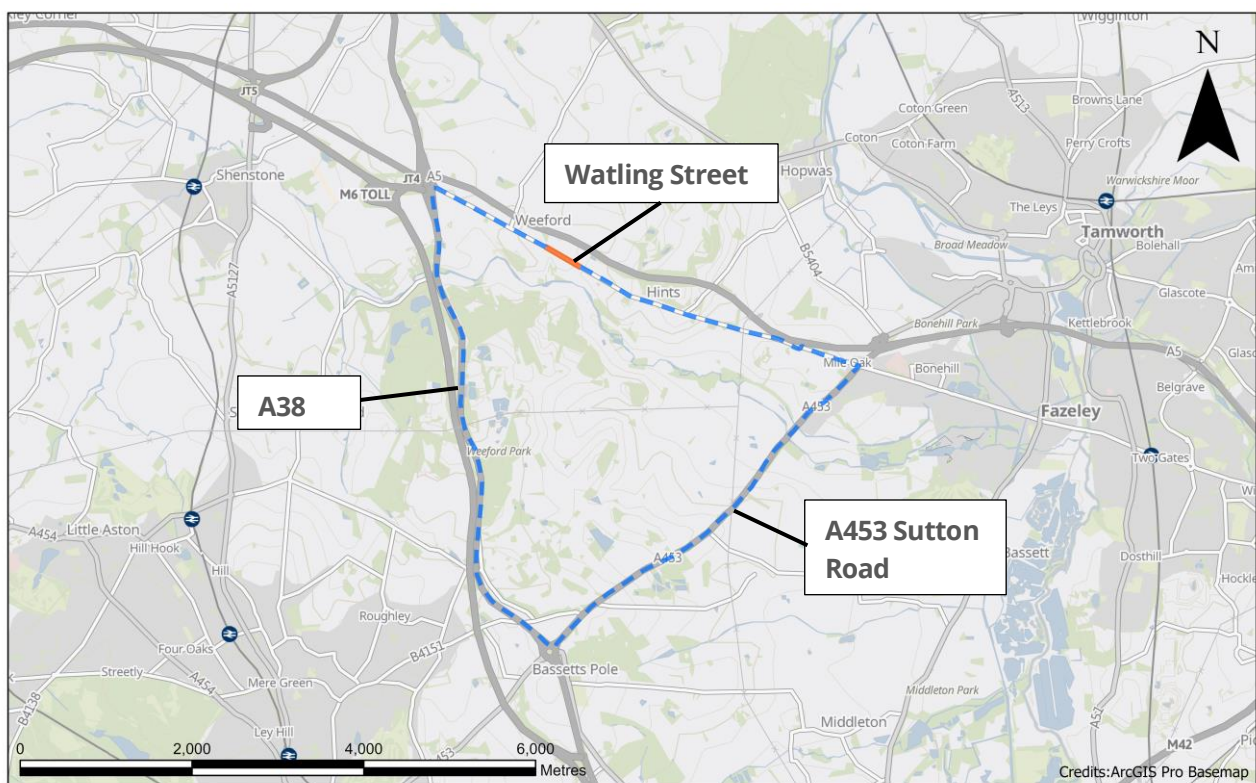
