High Speed Two (HS2) is the new high speed railway for Britain.

Project update

On 4 October 2023, the Prime Minister announced that the Government proposes to deliver a broad range of transport initiatives in place of investing in Phase Two of HS2. This means that HS2 Ltd is not undertaking any 'new' work to progress plans for Phase 2a of the project and is working with Government to agree the next steps on this phase of the project.

The activity described below is needed either to finish work on an existing site, for the ongoing maintenance of a site, or for health, safety and security reasons.

In 2022, Cadent completed work to move an underground gas pipeline near the A51, north-east of Swynnerton. Cadent will now be carrying out work to add additional protections to the relocated pipe, to ensure a safe and reliable gas supply.

What are we doing?

To enable the condition of the pipeline to be monitored throughout its life, Cadent will be carrying out additional work on land off Tittensor Road from **19 February 2024**.

The work will involve digging down to connect a cable to the pipeline and relocating a small test post.

Cadent expects to complete the work and reinstate the topsoil by **23 February 2024**.

Vehicles will be travelling via the A51 to reach the site access off Tittensor Road.

How will this affect you?

A small welfare cabin will be installed on land off Tittensor Road while the works take place.

People and equipment will be on site, and as the work will be low level we don't expect it to cause any disruption to local people.

All work will take place inside usual working hours. There will be no disruption to your utilities during the work. We will keep people updated as work progresses.

- Inform people in advance of any changes

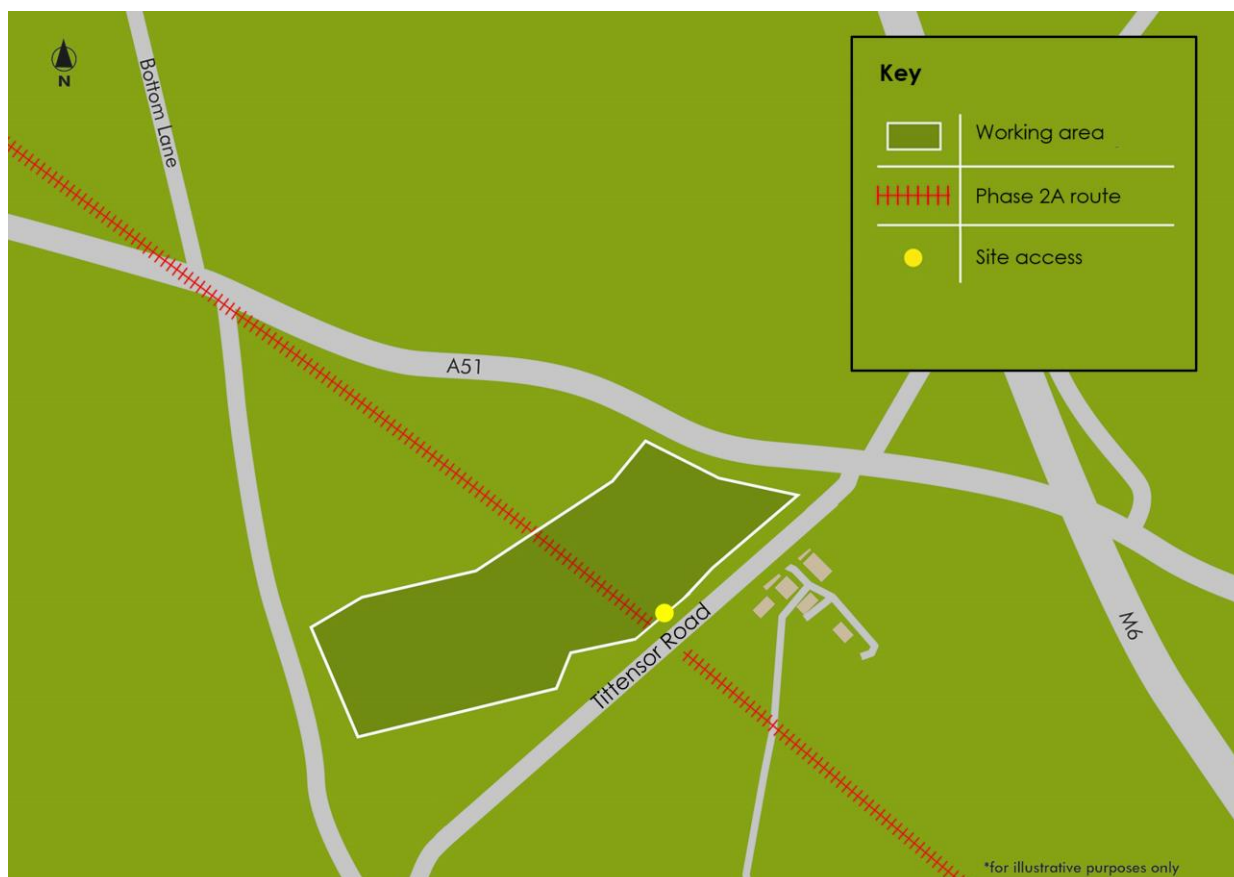
