



Notice of footpath and lane closure A4010, Risborough Road



What are we doing?

We will be carrying out necessary general maintenance and de-vegetation works along Risborough Road. A section of hedge in the area of the closure will also need to be removed to complete a utility diversion.

To carry out these works safely, a section of the A4010 will be under 3-way temporary traffic lights and a section of footpath will be inaccessible. This is for safety reasons as our operatives will be working in and around the carriage way.

When will these works take place?



- Wednesday 28 February and Thursday 29 February between 9:00am – 3:00pm

These dates may change due to conditions outside of our control but we will endeavour to complete them in or around the dates suggested above.

Please refer to the HS2 website regularly to check for any changes and updates.

Access will be maintained for residents and emergency services.
