What are we doing?

During the first three weeks of March, we will be operating the concrete batching plant at our Greatworth compound for extended hours, until 4am each weekday. This is to supply concrete for overnight construction work that is taking place on Westbury Viaduct, near Brackley.

For safety reasons, lighting will be on throughout the night and there may be some operational noise from vehicles and other machinery.

When will these works take place?

Overnight working will be taking place from Thursday 29 February to Wednesday 20 March 2024. The batching plant will be in operation from 8am until 4am, Monday to Friday during this period.

Depending on weather conditions, which may affect the planned construction activities, these date may vary slightly or be rescheduled.

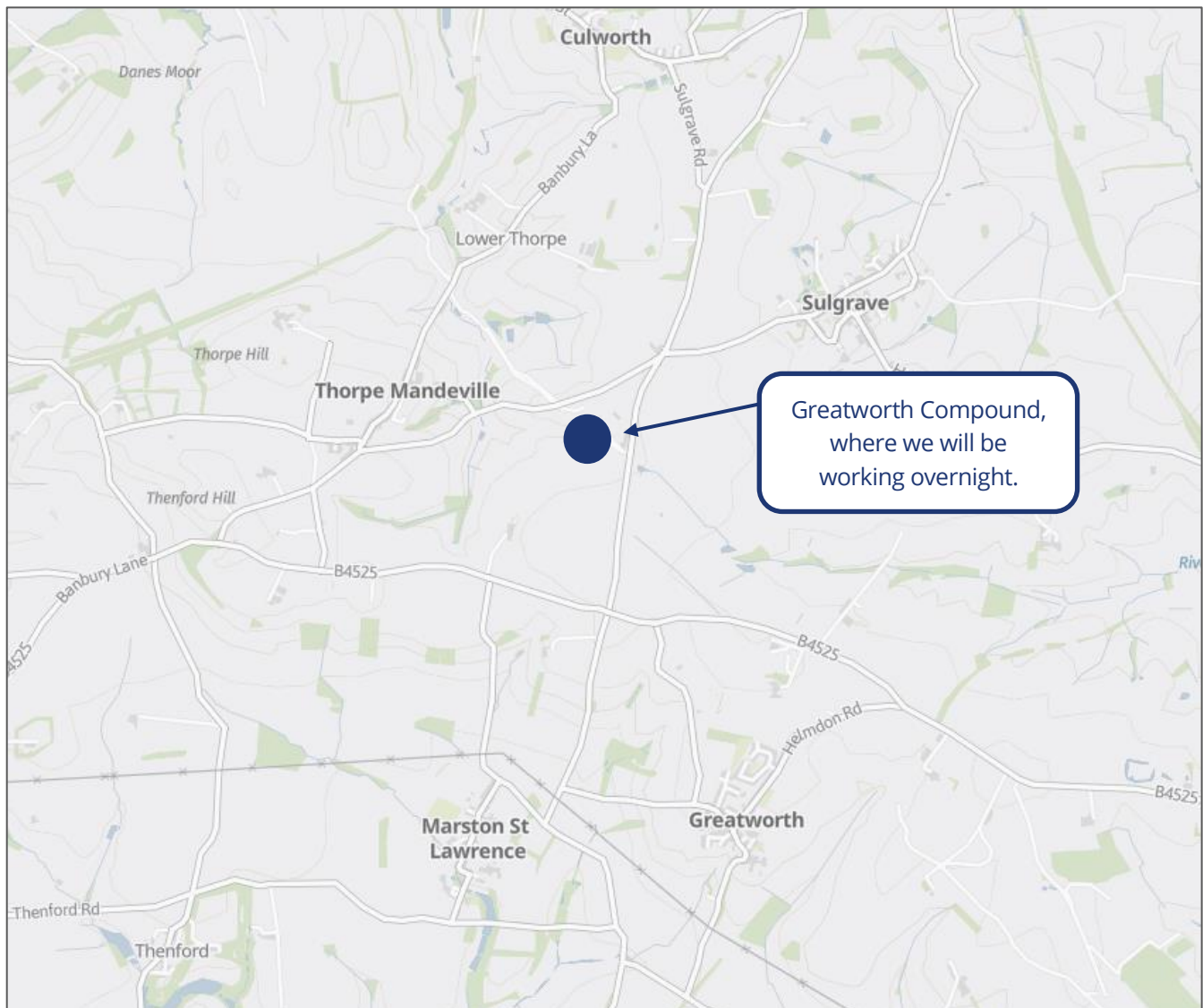
