High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We previously installed traffic management on Gilson Road, to prepare for the construction of the pier that will form part of the Water Orton Viaduct. The preparation work is now complete and we will be installing a one night closure of Gilson Road to remove the current traffic management.

When the work will take place

To ensure the safety of our workforce and road users, we will be installing an overnight closure of Gilson Road from 8pm Sunday 18 February to 5am Monday 19 February.
