High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be undertaking utility diversions along Watton Lane. To complete these works safely we will be operating temporary two way traffic lights between Gilson Road and the A446 Lichfield Road. This will result in single lane closure of Watton Lane between Gilson Road and the A446.

When the work will take place

The work will take place from Monday 4 March to Friday 15 March. The traffic lights will be in place 24 hours a day, seven days a week.
