To continue our works in the area, we will be undertaking improvement works on the M42, M6 toll road on both the eastbound & westbound carriageways, to update the street lighting.

A breakdown of the work

The end date of the work which commenced in January has been extended and one more shift is required. This will result in overnight lane closures from 9pm on Monday 4 March to 5am on Tuesday 5 March.
