Upcoming works on Park Village East north

High Speed Two (HS2) is the new high speed railway for Britain.

Extension of the lorry lay-by and new site access install for a future office and welfare building – March to May

From 4 March we will begin works to install a new staff access to our worksite at the northern end of Park Village East and extend our lorry lay-by to enclose this access.

We will use hand tools to remove a small section of the Park Village East wall between 1 Park Village East and our lorry lay-by to create this access. We will excavate the land behind and pour concrete from within our lorry lay-by. We will remove the excavated material from track level using our tower crane to reduce the impact to residents and road users.

We will take around six to eight weeks to complete these works. We expect some of these works to be noisy and will monitor noise levels closely to ensure we are working within the approved limits. We will also use noise blankets where possible. We apologise in advance for any disruption these works might cause.

Our staff access to the future office and welfare building will be used 24/7 once we begin tunnelling, which is currently scheduled for 2026.

Road closure on Park Village East – 4 to 5 March

On 4 and 5 March we will close the road, and a section of the footpath at the northern end of Park Village East to install temporary fencing prior to starting works. Resident vehicles will be able to access their properties at all times. We will reopen the road to general traffic on 6 March once the temporary fencing is installed and start works within it.

Once we complete works in this area, we will remove the temporary fencing, extending the lorry lay-by hoarding to just south of 1 Park Village East to enclose the new access.

We will need to close the road at the northern end of Park Village East again while we extend the hoarding. We will inform you of the actual dates nearer to the time.

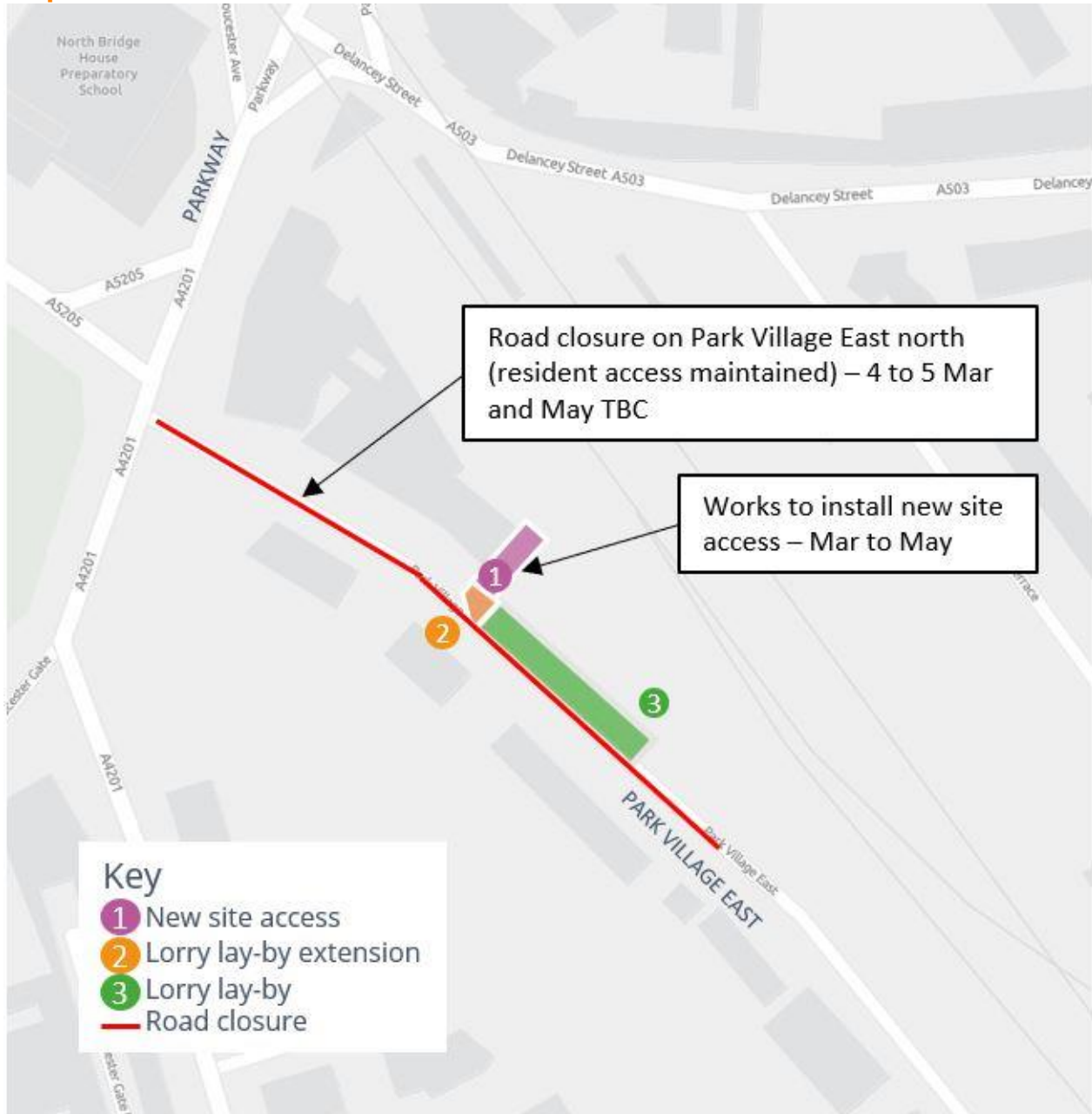
