# What we are doing - 24 Hour works, 5 days a week

We have reviewed our programme of works to ensure that we can continue the safe construction of the main ventilation shaft and the tunnel work in the satellite shaft. We want to ensure that there is a seamless transition from the completion of the shafts to the commencement of the headhouse construction.

This means that we will need to increase our working hours to 24 hours a day, five days a week from 4 March 2024 until 2 August 2024, we will keep you updated if this changes.

We will minimise the works we carry out at night, and we will use acoustic barriers around the construction machinery to reduce the noise. Noise and vibration levels will be continually monitored.

We would like to apologise in advance for any disruption or inconvenience the increased working hours may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way.

We will ensure that disruption is kept to a minimum and that regular updates are provided.
