High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

To enable the construction of the new railway we will be working on Gilson Drive to undertake trial holes, to help us investigate utilities in this area. This will be to understand if there are any existing utilities that we are not currently aware of. The traffic management is to ensure the safety of the road users and our workforce.

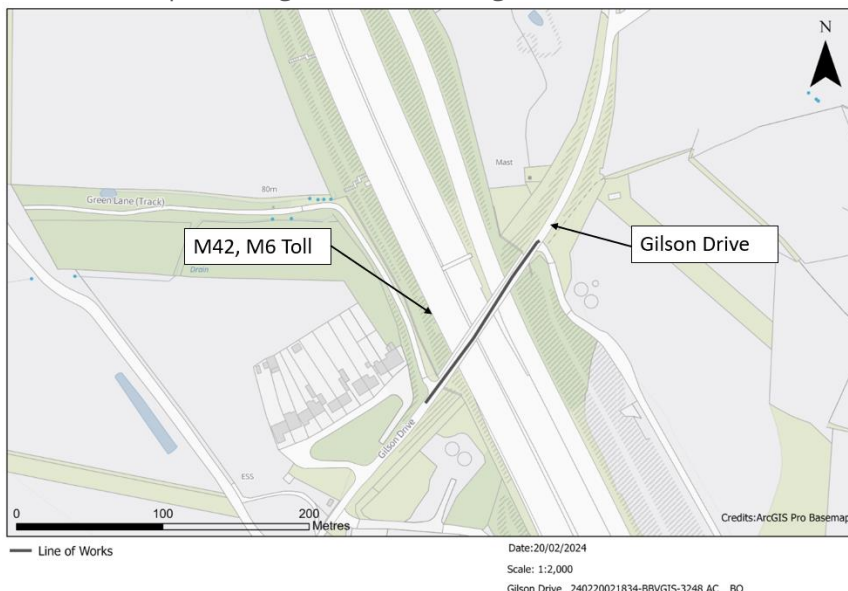
When we will do the work

UPDATED: Due to programme rescheduling, these works will now take place from Monday 25 March to Friday 5 April. The closure will be in place from 8am to 6pm each day.
