







Update on utility works and bridge surveys on Greenford Road, Ealing

High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

We wrote to you in September 2023, to let you know that we would be installing a new gas main on Greenford Road from 24 September 2023 to 18 March 2024. These works are ongoing, however we will be extending the traffic management further down Greenford Road towards Bennetts Avenue while we dig a pit on the pavement. Access will be maintained to the properties, adjacent to the extension, during these works.

Bridge surveys

We will be undertaking night-time bridge surveys on Greenford Road utilising the current site set up. These works will be on **16 and 17 February 2024 between 9pm and 5am**.

We will be installing monitoring equipment on the underside of the railway bridge on Greenford Road.

We will erect a mobile scissor lift platform within the work areas shown on the map overleaf so that we can carry out the installations safely.

There will be a pedestrian footpath closure so that we can work safely. A diversion route will be in place. We will then move to the other side of the road so that we can install the monitoring equipment on the opposite underside of the bridge.

Traffic management with a lane closure and temporary traffic lights will be in place on Greenford Road 24 hours a day for the duration of these works.

What to expect

Temporary work site on Bennetts Avenue and lane closure on Greenford Road

Noisier works during excavation. We will use an excavator with breaker attachment to break out the concrete, and an excavation vacuum to remove waste material

Traffic management with a lane closure and temporary traffic lights will be in place 24 hours a day during these works

What we will do

Maintain access for pedestrians

Use noise reducing barriers around areas where we are digging and drilling

How the utility works might affect you

During the daytime, we will be using an excavation vacuum to remove the soil from any dig sites, and we expect that this will create some noise. We will restrict the use of this equipment as much as possible and install noise reducing barriers to minimise the impact this might have on residents.

Some parking bays on Greenford Road will be suspended and driveway access restricted due to the works. Residents who are impacted will be contacted directly.

We would like to apologise for the disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way possible.
