



# Notice of traffic management on the A446 Lichfield Road, Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be diverting utilities along the A446 Lichfield Road. To complete these works safely we will be installing a lane closure and temporary traffic lights on the A446 Lichfield Road at the junction of Watton Lane.

## When the work will take place

The work will take place from Monday 18 March to Sunday 26 May. The lane closure and traffic lights will be in place 24 hours a day, seven days a week, however our working hours will start at 8am and finish at 6pm each weekday.

## Duration of works

Temporary lane closure on the A446 Lichfield Road from Monday 18 March to Sunday 26 May 2024

Our working hours will be from 8am to 6pm each day

The lane closure and traffic lights will be in place 24/7

Our workforce may be on-site up to one hour before and after to set up and secure
