



# Updated: Notice of traffic management on the A446 Lichfield Road and Watton Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing


To continue our preparation for the construction of the HS2 railway, we will be diverting utilities along the A446 Lichfield Road and Watton Lane. To complete these works safely we will be installing a lane closure and temporary traffic lights on the A446 Lichfield Road and Watton Lane.

## When the work will take place

UPDATED: Due to unforeseen circumstances, these works have been delayed and will now end on Sunday 9 June. The lane closures and traffic lights will be in place 24 hours a day, seven days a week, however our working hours will start at 8am and finish at 6pm each weekday.

## Duration of works

UPDATED: Temporary lane closures on the A446 Lichfield Road and Watton Lane from Monday 18 March to Sunday 9 June 2024

Our working hours will be from 8am to 6pm each day

The lane closures and traffic lights will be in place 24/7
