High Speed Two (HS2) is the new high speed railway for Britain. EKFB is working in partnership with HS2 Ltd to build the new high speed railway in your area. You can sign up for regular updates in your local area at www.hs2innorthants.co.uk.

What are we doing?

POSTPONED: The Wormleighton Road closure planned for March 2024 has been postponed. We will issue an update when new closure dates are confirmed.

On the border between Warwickshire and West Northamptonshire, we have been building a new road bridge, as well as new sections of highway within our construction area. Once open, these will enable local roads to pass over the HS2 railway line.

Since August, Banbury Road near Boddington has been closed while we connect it to our recently constructed Banbury Road overbridge.

In mid March, there will be an additional road closure of Wormleighton Road. The work involves raising the height of Wormleighton Road and connecting it to a new section of highway.

The temporary closure of Wormleighton Road means that access to Stoneton Lane will be limited. Traffic using Stoneton Lane will only be able to travel to and from the Boddington direction. In April, Stoneton Lane will close for approximately 18-24 months while we build the Stoneton Lane green overbridge.

When Wormleighton Road re-opens, vehicles will follow a new road layout that passes over the new Banbury Road overbridge.

When will these works take place?

Our planned closure of Wormleighton Road, from Monday 18 March to Monday 15 April 2024 has been postponed.

A section of Wormleighton Road will be fully closed from Monday 18 March to Monday 15 April 2024.

Banbury Road will reopen on Monday 15 April.

There will be limited access to Stoneton Lane, near Priors Hardwick.

Noise from plant and machinery. Some weekend and evening work may be required.

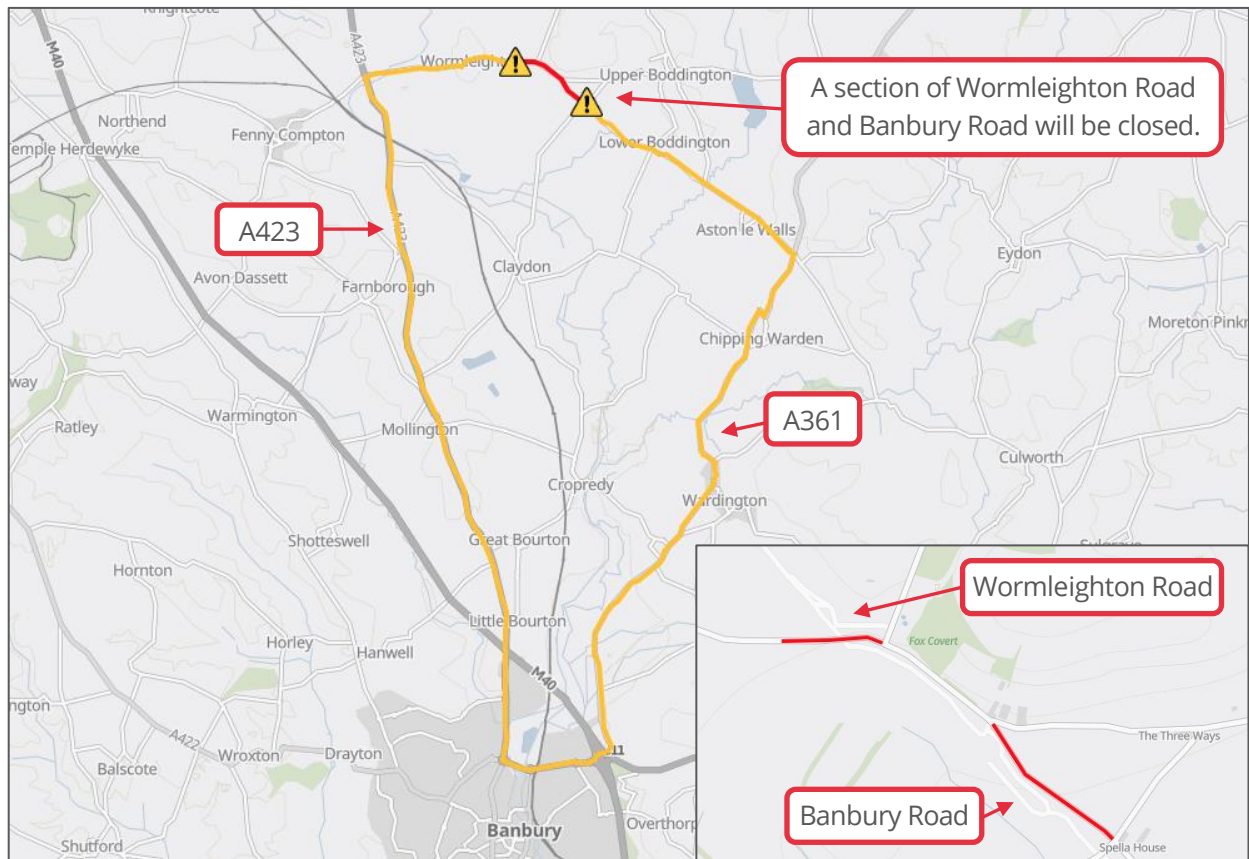

Where will the works take place?

POSTPONED: The Wormleighton Road closure planned for March 2024 has been postponed. We will issue an update when new closure dates are confirmed.

The map below shows the section of Wormington Road that will be fully closed 24-hours a day, from Monday 18 March until Monday 15 April 2024. As well as a section of Banbury Road, also closed until Monday 15 April 2024.

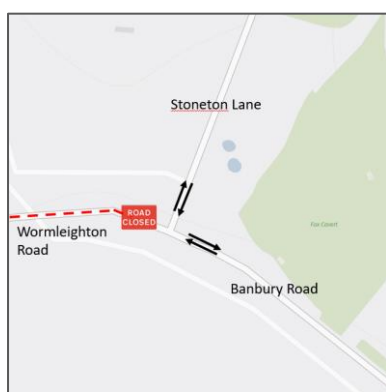

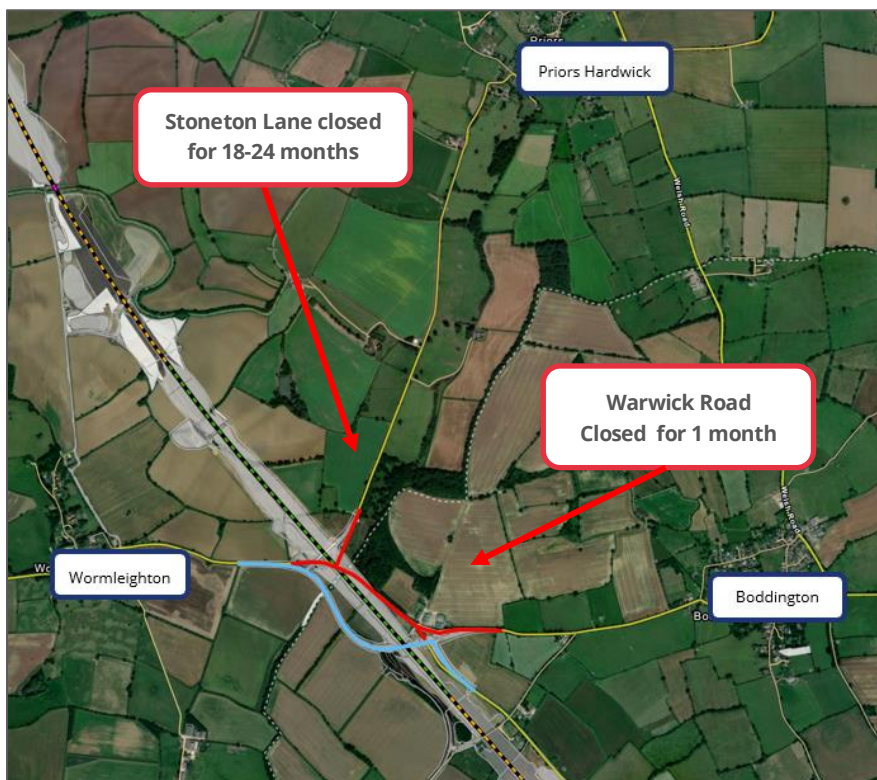
POSTPONED: The Wormleighton Road closure planned for March 2024 has been postponed. We will issue an update when new closure dates are confirmed.

Next phases:

- In addition to the current Banbury Road closure, Wormleighton Road will be closed for 4 weeks.
- At the junction with Stoneton Lane (also known as Leisure Drive) vehicles will only be able to turn to and from the Boddington direction.



- Banbury Road and Wormleighton Road will be open with traffic passing over the new Banbury Road overbridge.
- Initially the bridge will open for single lane traffic, controlled by temporary traffic lights. Permanent bridge parapets will be installed later in 2024.
- Warwick Road will be closed for approximately 1 month.
- Stoneton Lane will be closed to excavate the cutting and build a new green overbridge for approximately 18-24 months.
