Notice of overnight road closure – A446 - Chester Road – Chelmsley Wood.



High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing.

BBV have significantly reconfigured the junction of the A446 Stonebridge Road and A452 Chester Road near Birmingham Business Park to facilitate the construction of a box structure (bridge) that will take the new railway over the M42. As these works near completion, we are making some improvements to the existing road networks in proximity to the new road network. Part of these improvements include installing brand new street lighting on Chester Road between Birmingham Business Park and Colehill Heath Road. To do this work safely we will need to close this part of Chester Road. To minimise the disruption, we will only close the road at night from 8pm until 6am between 22 April and 26 April.
