# **Update: Hampstead Road utility diversion works**

High Speed Two (HS2) is the new high speed railway for Britain.

### Hampstead Road temporary utilities diversion update


We previously informed you about our programme to divert utilities on Hampstead Road between Granby Terrace bridge and Varndell Street. We are carrying out this work in phases with varying traffic management for each. See table on page 2.

We are currently working within the traffic management set-up in the northern section, near Granby terrace bridge. See map with details on page 2.

### Varndell Street closure - 14 October 2024 to May 2025

We will begin work in the southern section on Hampstead Road, near Varndell Street, on 14 October. We will close Varndell Street until May 2025 for our utility work. Vehicle access will be maintained via William Road and Robert Street.

From 7 to 15 October, as part of our utility work, we will remove a section of hoarding in front of Cartmel. We will replace it with temporary fencing to ensure we have enough space to complete our work. We will also narrow the northbound lane on Hampstead Road while maintaining two-way traffic. We apologise for any inconvenience this may cause.



### **Current phase - northern section - ongoing till November 2024**



During this phase of works, we have closed a section of the northbound footpath and cycle lane on Hampstead Road near Granby Terrace bridge.

Pedestrians are being diverted onto the new temporary crossing.

We will move the pedestrian crossing back to the original location on completion of this work.

### Phases of utilities diversion between Granby Terrace bridge and Varndell Street
