



# Notice of remaining works for electricity pylon diversion scheme, Colne Valley

High Speed Two (HS2) is the new high speed railway for Britain.

### What we are doing

In Spring 2024 National Grid will remove the remaining temporary bridge over the River Colne and associated infrastructure that's been in place for its HS2 pylon diversion scheme. Reinstatement of the area will follow.

### When the work will take place

Our contractor, Morrisons, will start the work 2 April 2024. It will take two and a half months to complete.

### What to expect

There may be some low-level noise, but we don't expect any disruption to residents.

None of the work will affect electricity supplies.

### **Duration of works**

2 April for around two and a half months.

Working weekdays and also alternate weekends starting 6 April. Weekend working hours are 8am to 1pm on Saturdays and 8am to 3pm on Sundays.

Four teams of four workers with approx. four vans, two MEWPs, diggers, dumpers and telehandlers. Lorries arriving to remove stone/bridge sections throughout.

### What we will do

Remove remaining temporary bridge over the River Colne and associated infrastructure.

Inform you in advance of any changes to the dates and working times shown.
