What are we doing?

UPDATE:

We are continuing to prepare the A361 in Chipping Warden for realignment of the highway over the Chipping Warden Green Tunnel.

In January and March we are carrying out trial holes to identify the utilities along the A361 near to the HS2 Chipping Warden Compound, just north of the village.

A section of the A361 will have traffic management for one week, incorporating the EKFB compound entrance, to complete this work.

When will these works take place?

UPDATE:

From Monday 18 March to Saturday 23 March 2024, for 24-hours a day.

This work is subject to approvals from the local authority and the dates of the work may change.

Duration of works

Traffic lights from 18 March to 23 March 2024, 24-hours a day.

Normal working hours: Monday to Friday 8am – 6pm Saturday and Sunday 8am – 6pm

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

What to expect

Our workforce in and near the road during the road closures and traffic management.

What we will do

Respond promptly to any complaints and take appropriate action.
