Three-month look ahead

Location of works	Proposed duration	Description of works
Location 1 Willesden Euroterminal	March to May 2024	The Willesden Euroterminal site will continue to operate as a rail terminal. Works planned during this period include:
(WET) site		 Receiving excavated material from other HS2 sites in the area, mostly by conveyor. However, some may still arrive by road; and
		The conveyor system will continue to operate from the Old Oak Common Station site to move excavated materials Monday to Friday 8am to 6pm.
		The conveyor system from the Victoria Road Crossover Box site will operate 24/7 to move excavated materials from the HS2 London Tunnels;
		Train movements and loading of rail wagons will continue to take place 24/7 to align with the national rail freight timetable. Each week, there may be up to 35 loaded train departures and six loaded train arrivals with tunnel segments. This will vary week to week; and
		 Two gantry cranes will be in operation to unload trains and load lorries to transport tunnel segments to the tunnelling sites on Victoria Road.
Location 2 Old Oak	March to May 2024	Construction activities will continue in the East Box during this period. The works will include:
Common East Box	 Deliveries of crane parts and other large plant machinery. Due to the size of the vehicles, these deliveries are expected to take place between 5am and 6am, to minimise the impact on the road network; 	
		 Removal of the tunnel boring machine components from the ground using a crane. The parts will be loaded onto a transport vehicle for removal from site;
		 Deliveries, excavations, concrete pours, sprayed concrete lining and steel works to prepare for future construction of the twin-

		bored Euston Tunnel. Some of these works will take place on a 24/7 shift pattern; and
		 Start of works to build sprayed concrete lining short sections of tunnel in advance of future tunnelling works.
		Some aspects of these works will require extended working hours. If extended working hours are required, we will send out information to the local community in advance.
Location 3 Atlas Road	March to May 2024	Works planned at the Atlas Road site during this period include:
site		 Operation of the conveyor to move excavated materials from other sites in the area to the Willesden Euroterminal site;
		 Removal of tunnelling equipment from the Atlas Road logistics tunnel including tunnel boring machine gantries and conveyor equipment. The parts will be loaded onto transport vehicles for removal from site;
		 Works to prepare the Atlas Road logistics tunnel for use, including construction of a roadway through the tunnel; and
		 Setting up of sprayed concrete lining plant and equipment.
		Some aspects of these works will require extended hours of working. Site lighting will be in place to support construction activities taking place during extended working hours.
		If extended working hours are required, we will send out information to the local community in advance.
Location 4 Old Oak	March to May 2024	Works are progressing well at Old Oak Common Station site. Works planned for this period include:
Common station site		 Construction of the internal site road and concrete surfaces;
		 Excavation of material and concrete structure works for the underground HS2 station;
		 Ground preparation works in the Great Western Main Line station;
		Piling* for the conventional station (the above ground platforms that will connect the HS2

		station to the Great Western Main Line and the Elizabeth Line services);
		 Excavation of material and concrete structure works for the conventional station associated buildings; and
		Operation of the conveyor to remove excavated materials from the Old Oak Common site towards the Willesden Euroterminal site, for transportation by train.
		*Piling = creating deep concrete foundations.
Location 5	March to May	Works planned on Old Oak Common Lane include:
Old Oak Common Lane	2024	 Traffic management associated with various construction work. This includes lane closures and traffic light signals;
		 Trial holes and surveys for the Old Oak Common Lane bridges;
		 Utility diversion works; and
		 Enabling works, earthworks, piling* and foundations for the Central Line and Old Oak Common Lane bridges.
		*Piling = creating deep foundations
Location 6 Victoria Road Flat Iron site	March to May 2024	We will continue to operate the vehicle holding area at this site to support construction at all HS2 sites in the Old Oak and North Acton area.
		Works at this site include:
		 Operation of the conveyor to move excavated materials to Willesden Euroterminal*;
		 Operation of the material laboratory;
		 Utility works within the site in preparation for future tunnelling works;
		 Operation of a batching plant to support the tunnelling works at the Victoria Road sites; and
		 Moving of materials by road to support tunnelling construction*.
		* Some aspects of these works may require extended hours of working. Site lighting will be in place to support construction activities taking place during extended working hours.

Location 7 Victoria Road Crossover Box site	hoy Those structures will regulate air flow n	
		We will also build the twin-bored HS2 London Tunnels from this site to Greenford.
		Ongoing works during this period include:
		 Construction of the crossover box, including base slab and headwalls (walls at the end of the below ground structure);
		 Construction of the tunnels that connect the ventilation shaft to the crossover box. These tunnels will be dug using an excavator*;
		 Launch and operation of two tunnel boring machines to build the HS2 London Tunnels westbound from the Victoria Road Crossover Box to Greenford*;
		 Operation of the on-site batching plant that will be used to produce concrete, and operation of the conveyor system*;
		 Start_of the construction of the internal concrete structure within the Victoria Road ancillary shaft; and
		 Movement of tunnel segments from Willesden Euroterminal to the Victoria Road Crossover Box site via road*.
		*Some aspects of these works may require extended working hours. Site lighting will be in place to support construction activities taking place during extended working hours.
		If extended working hours are required, we will send out information to the local community in advance.
Location 8 Wormwood Scrubs	March to May 2024	The sites currently fenced on Wormwood Scrubs will stay in place while utilities are diverted in the future. The compound will be re-established, with some vegetation clearance, to accommodate construction activities and site welfare.

Works impacting the road network	March to May 2024	We are continuing to carry out utility protection works in various locations along the HS2 London Tunnels route, including Victoria Road.
		Further details and dates for any other utility protection works remain subject to ongoing surveys and utilities design work.

Location 1 Willesden Euroterminal	Summer 2024 to summer 2025	The Willesden Euroterminal site will continue to operate as a rail terminal. Works planned during this period include:
site (WET)		 Receiving excavated material from other HS2 sites in the area, by road and conveyor;
		 Operation of the conveyor system from the Old Oak Common Station site to move excavated materials on Monday to Friday from 8am to 6pm;
		 Operation of the conveyor system from the Victoria Road Crossover Box site 24/7 to move excavated materials from the HS2 London Tunnels towards Greenford;
		 Train movements and loading of rail wagons will continue to take place 24/7 to align with the national rail freight timetable. Each week, there may be up to 35 loaded train departures and six loaded train arrivals with tunnel segments. This will vary week to week; and
		 Two gantry cranes will operate to unload trains and load lorries to transport tunnel segments to tunnelling sites on Victoria Road.
Location 2 Old Oak Common East Box	Summer 2024 to summer 2025	Construction activities will continue in the East Box during this period. The works will include:
		 Construction of a roadway in the Atlas Road logistics tunnel ready for use during construction of the London Tunnels towards Euston;
		Works to build sprayed concrete lining short sections of tunnel in advance of future tunnelling works using tunnel boring machines; and

		Assembly of two tunnel boring machine front shields.
Location 3 Atlas Road site	Summer 2024 to summer 2025	Works planned at the Atlas Road site during this period include:
		Operation of the conveyor to move excavated materials from other sites in the area to the Willesden Euroterminal site;
		 Operation of gantry cranes to move concrete tunnel segments;
		 Construction of a roadway in the Atlas Road logistics tunnel ready for use during construction of the London Tunnels towards Euston; and
		 Utility works in the Atlas Road logistics tunnel.
		Some aspects of these works may require extended hours of working. If extended working hours are required, we will send out information to the local community in advance.
Location 4 Old Oak Common Station site	Summer 2024 to summer 2025	Construction activities will continue at the Old Oak Common Station site during this period. The works will include:
		 Construction of the internal site road and concrete surfaces;
		 Excavation of material and concrete structure works for the HS2 underground station;
		 Piling*, excavation and foundation works for the shared accommodation building;
		Ground preparation works in the Great Western Main Line station;
		Piling* and platform construction for the conventional station (the above ground platforms that will connect the HS2 Station

Location 5 Old Oak Common Lane	Winter 2025 to summer 2025	to the Great Western Main Line and the Elizabeth Line services); • Great Western Main Line station platforms construction and canopies installation; • Concrete blocks to be constructed in both the HS2 and conventional station; and • Operation of the conveyor to remove excavated materials from the Old Oak Common site towards the Willesden Euroterminal site, for transportation by train. *Piling = creating deep concrete foundations. Works planned on Old Oak Common Lane during this period include: • Enabling works, piling* and foundations for future bridge construction above Old Oak Common Lane; • Old Oak Common Lane utility diversion works; and • Old Oak Common Lane bridge construction. *Piling = creating deep foundations. We are currently exploring a number of options to undertake the works on Old Oak Common Lane which require a road closure, and we are at the very beginning of this process. No decisions have been made and we will be working closely with the local authorities, Transport for London, emergency services, local communities, businesses and others to plan these works.
Location 6 Victoria Road Flat Iron site	Summer 2024 to summer 2025	We will continue to operate the vehicle holding area at this site to support construction at all HS2 sites in the Old Oak and North Acton area. Works planned during this period include: Operation of the conveyor system in this site to move excavated materials to Willesden Euroterminal*; Utility works within the site in advance of future tunnelling works. These works are

- being carried out from July next to the Network Rail tracks; Receiving concrete tunnel segments to this site to support the future construction of
- Operation of the batching plant currently to support tunnelling works; and
- Operation of the material laboratory.

the Northolt East Tunnels*;

*Some aspects of these works may require extended working hours. Site lighting will be in place to support construction activities taking place during extended working hours.

If extended working hours are required, we will send out information to the local community in advance.

Location 7 Victoria Road Crossover Box site

Summer 2024 to summer 2025

Works will continue in the Victoria Road Crossover Box site to build the ventilation shaft and crossover box. These structures will regulate air flow, provide access to the tunnels, and allow trains to switch tracks as they enter the future Old Oak Common station.

We will also build the twin-bored HS2 London Tunnels from this site to Greenford.

Work will include:

- Construction of the tunnels that connect the Victoria Road crossover box to the Old Common station site. These tunnels will be dug using an excavator and built using the sprayed concrete lining method;
- Operation and maintenance of the conveyor system and on-site batching plants*;
- Operation and maintenance of two tunnel boring machines as they build the twinbored London tunnels towards Greenford*;
- Delivery of tunnel segments;
- Construction of the internal concrete structure within the Victoria Road ancillary shaft; and
- Construction of tunnel cross passages.

	*Some aspects of these works may require extended working hours. Site lighting will be in place to support construction activities taking place during extended working hours.

Summer 2024 to summer 2025	Utility diversion works, passing through the previously installed tunnels through the Wormwood Scrubs compound and connecting to existing utilities in Old Oak Common Lane.
Summer 2024 to summer 2025	We will be carrying out utility and bridge surveys and protection works at various locations along the HS2 London Tunnels route. Any works on the road network in the Old Oak and North Acton area will be coordinated to minimise impact to local communities and road users. We will write to you in advance of any utility surveys or utility works that might impact you.
Summer 2024 to summer 2025	We will carry out surveys, monitoring and protection works for some structures along the HS2 London tunnels route. We will write to you in advance of any works that may impact you.

- We have local community websites and newsletters with regular information and updates about our work in your area.
- We have local community teams who know your area. They will hold local events and run projects to keep you informed.

Involving

- We will involve you in opportunities to benefit and learn as we build HS2 including jobs, skills, education, employment and funding.
- We will ask you about the design of specific parts of the railway.

Responding

- Our dedicated HS2 Helpdesk is available 24 hours a day, every day of the year, to help with any questions or concerns you have about HS2 or our work.
- If things go wrong, we have a complaints process and a dedicated complaints team.
- An independent Construction Commissioner monitors how we manage and deal with complaints.

Consulting

- We will hold formal consultations with you while we seek permission to build Phase 2b of HS2.
- We now have permission to build Phase One and Phase 2a. This means we will only formally consult on this part of HS2 when we need permission to do things that fall outside the terms of the legislation agreed by Parliament.

Keeping you informed

We are committed to keeping you informed about work on HS2. This includes ensuring you know what to expect and when to expect it, as well as how we can help.
