## The work we will be doing

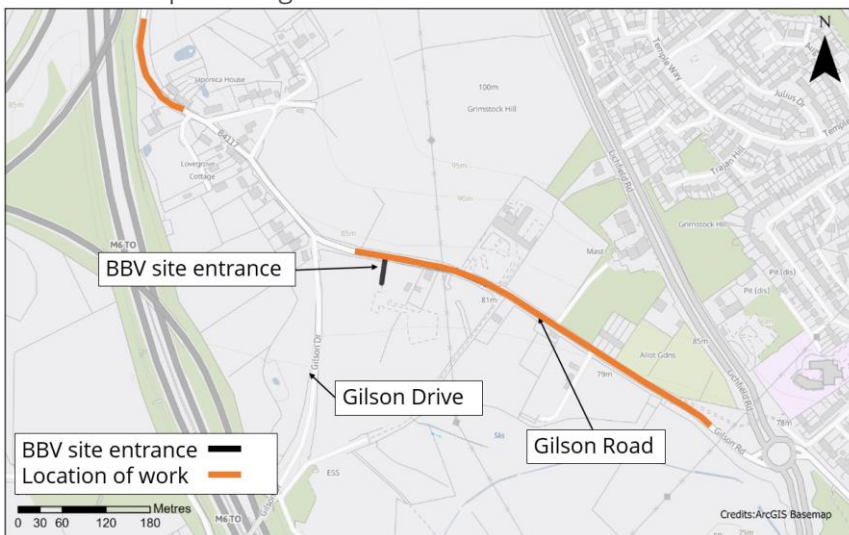
To continue our preparation for the construction of the HS2 railway, we will be working along Gilson Road to repair potholes.

## When the work will take place

Updated- Due to unforeseen circumstances the date for these works have been delayed by one week. To ensure the safety of our workforce and road users, we will be using stop & go signals and traffic lights on Gilson Road from 9:30am to 3:30pm on Monday 18 March.
