# Notice of lane closure on Adelaide Road

High Speed Two (HS2) is the new high speed railway for Britain.

## **Concrete pour**

From 6am to 6pm on Thursday 21 March, there will be a lane closure on Adelaide Road, as concrete will be poured to construct the base slab for the future headhouse.

The closed lane will be used to accommodate a concrete pump, specifically the M36 model, which is too large to fit within our construction site.

The approximate location of the closure is shown on the map below.



## How will this affect you?

3-way temporary traffic lights will be in use.

Bus stop R, Eton Road, towards Chalk farm will be suspended. The closest alternative stops are Stop CA, Chalk Farm Station, or stop P, Adelaide Medical Centre.

You may experience additional noise from the concrete pump, and from vehicles entering and leaving the site.
