



Notice of traffic management on A46 Kenilworth Bypass

High Speed Two (HS2) is the new high-speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We are constructing a box structure to take the A46 in Kenilworth over the new HS2 line. We recently notified you of our previous phase of work taking place in April. As part of the next phase of our programme we need to complete some further works, which includes:

- Installing temporary vehicle restraint systems to support the flow of traffic and ensuring the safety of our workforce
- Installing CCTV to monitor the flow of traffic
- Widening the embankment next to the carriageway
- Realigning drainage ahead of carriageway drainage work later in our programme.

When will these works be taking place?

To complete our work safely, we will fully close the northbound and southbound carriageways overnight between Thickthorn Roundabout and A45 Stivichall Interchange on the following dates:

- **Northbound carriageway closure on 21 May from 8pm until 6am on 22 May** to install the temporary vehicle restraint system.
- **Southbound carriageway closure on 22 May from 8pm until 6am on 23 May** to install the temporary vehicle restraint system. We will also extend the lane one closure currently in place by Warwickshire County Council during the southbound overnight closure.

Once Warwickshire County Council works are complete, lane one restrictions will remain in place in both directions until October 2024 while we complete our work.

Where we will be working

We will be working on the **A46 Kenilworth Bypass** between the **Thickthorn Roundabout** and **A45 Stivichall Interchange**. You can see a map showing the diversion routes on the following page.

Duration of works

Overnight northbound carriageway closure on 21 May

Overnight southbound carriageway closure on 22 May

Lane one restriction in both directions will remain in place until October 2024

What to expect

Fully signed diversion will be in place

Minor disruption to your travel times

Our workforce may be on site one hour before and one hour after, to set up and secure our equipment.

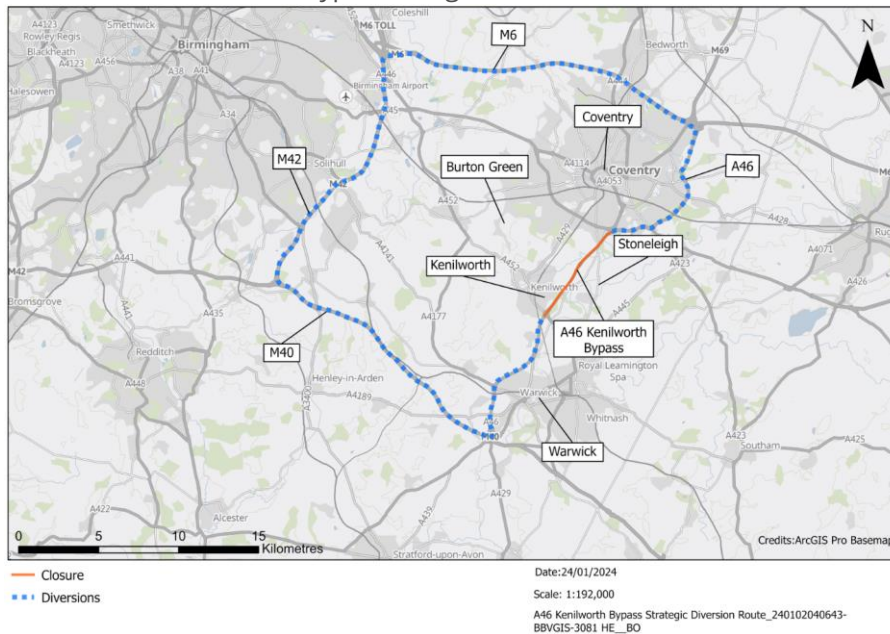

Diversion route one (for HGVs only)

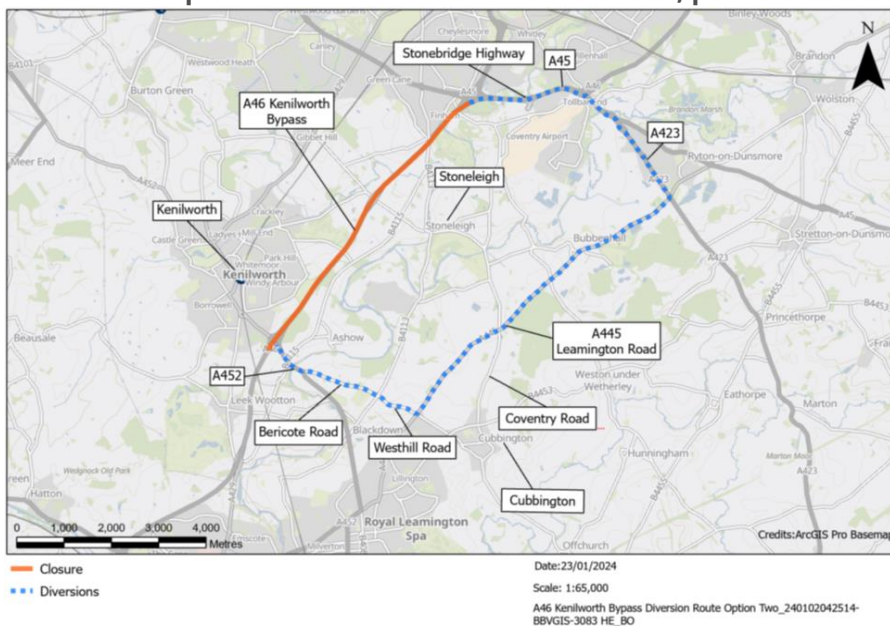
During both overnight closures, all HGVs must follow the diversion route below. Vehicles are diverted from the A46 Kenilworth Bypass along the M6, M42, M40 and back on to the A46.



For local traffic; diversion route two (not suitable for HGVs)

We will install a fully signed diversion route directing road users along the A45, A423, A445 Leamington Road, Westhill Road, Bericote Road, A452 to rejoin the A46.

HGVs are not permitted to use this diversion route, please see below for further details.

A46 Box

The A46 Box structure will take the A46 in Kenilworth over the HS2 line. The structure will weigh approximately 15,000 tonnes and made up of 4,300 cubic metres of concrete and 120 concrete beams. You may have noticed the structure being constructed next to the A46. Once we have built the structure, it will be moved into place across the existing carriageway in early 2025.

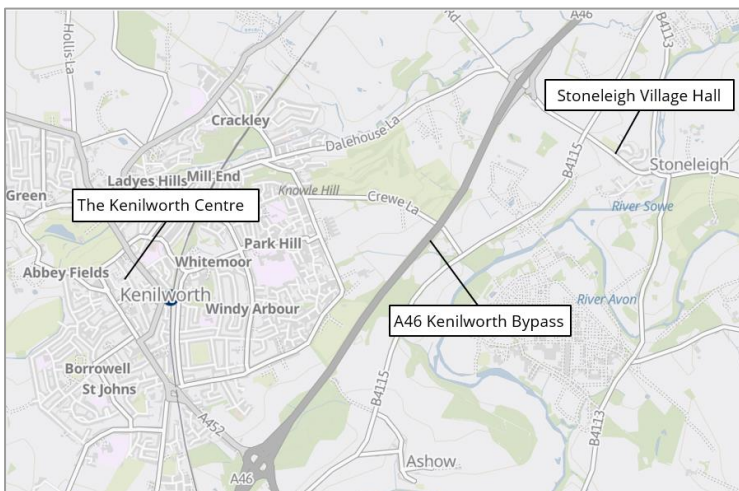
