### **Update: Utility works in Brunswick Road area**

High Speed Two (HS2) is the new high speed railway for Britain.

#### **Ongoing works: West Gate Gas Diversion**

From **15 April to 29 May, between 8am to 6pm**, we will be carrying out works on Brunswick Road. We are writing to you with further update about these works following our last update on 10 April.

Due to ongoing Cadent Gas works in the local area and feedback from local residents, we have made some changes to minimise disruption to you as much as possible during our works.

**From 15 April**, works have started on the Brunswick Road footpath opposite Brentham Way, leading to Brentham Meadows and the allotments. We have installed a footpath closure only.

Cadent Gas are finalising their work in the local area and we are working together where possible to reduce the disruption.

**From 22 April,** we will reinstall a road closure on Brunswick Road and start works to protect the gas mains below the road. We have changed the diversion route following a review of the traffic numbers. You can view a map of the new diversion route on page two. This has been agreed with Ealing Council

We no longer require a road closure on Ruskin Gardens. Our team had planned to install staff welfare facilities at this location. These will now be installed within the road closure area on Brunswick Road.

The works will be carried out in phases, as shown in the map below. The dates are indicative, and subject to change. The below traffic management phase will begin from 22 April until 29 May 2024




#### Future works in the Brunswick Road area in 2024
