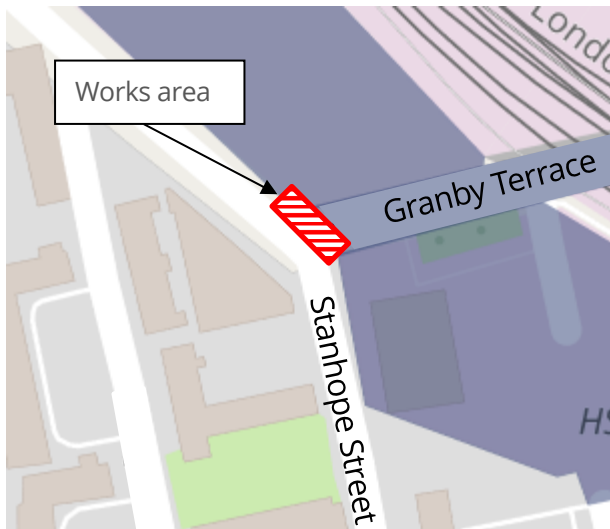
High Speed Two (HS2) is the new high speed railway for Britain.

## Weekend and extended hours work within site near Stanhope Street site entrance – 15 and 16 June

Throughout April and May, we carried out our utility diversion works at the corner of Stanhope Street and Park Village East. We now need to return to the area to complete the final section within our site access gate. We previously told you we would complete this in May, but we were unable to do so. We are now planning to carry out this work on Saturday 15 June and Sunday 16 June from 8am to 5pm. We need to complete this work over the weekend, so it does not impact internal access to the site.

You may notice brief periods of increased noise while we are breaking concrete. We plan to complete all noisy works between 8am and 1pm on Saturday to minimise the impact to local residents.

We apologise for any disruption these works may cause.

## Works at Granby Terrace bridge – Saturday 8 June and Saturday 15 June

We are currently working to extend Granby Terrace bridge. We will continue to work weekends on Saturday 8 June and Saturday 15 June to continue building the formwork and complete other preparatory tasks. We will carry out this work between 8am and 5pm.

We will complete all noisy works between the hours of 8am and 1pm. We apologise for any inconvenience these works may cause.

## Weekend and extended hours site maintenance – Saturday 15 June

Our sites, offices and equipment require regular planned and unplanned maintenance. We frequently carry out maintenance work during extended hours when the office or worksite is not in use, and we can safely disconnect utilities or lift large equipment. This work is generally quiet, and we don't expect neighbours to notice.

We also carry out regular maintenance to our site hoarding once a month on a Saturday. We will carry out this work on Saturday 15 June from 8am to 1pm. We will temporarily close the northbound lane on Hampstead Road and maintain two-way traffic in the southbound lane. We will also use this traffic management to remove the tree next to Cartmel that we previously informed you we would carry out in May.

You may notice brief periods of noise as we complete these works. We apologise for any inconvenience caused.

## Ongoing surveys and monitoring at track-level within the Euston Approaches

We carry out regular surveys and monitoring of the bridges and structures within the railway cutting, to inform and assess the impact of our works. For safety, due to the location of these structures beside, above and below the railway tracks, we can only carry out these surveys when the tracks are not in use. This means we frequently carry out surveys during weekends and overnight shifts.

## About our Community and Business Funds

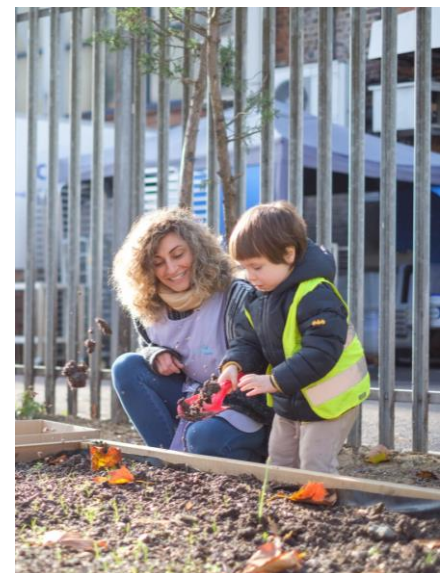
