High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

We will be undertaking utilities surveys on Bangley Lane that will require a full two-week closure. This will be to establish what utilities are beneath the road and what condition they are in ahead of future construction works. To complete these works safely we will need to implement a safe working area that will require the full closure of Bangley Lane.

When the work will take place

We will install a full closure on Bangley Lane to complete utilities surveys as follows:

- **28 May to 10 June 2024** 24 hours per day (Including weekends). Our working hours will be 8.00am to 6.00pm and if required 8.00am to 1.00pm Saturday.

Access will be maintained for pedestrians, cyclists, and equestrians from either end of Bangley Lane.

Full lane closure from 28 May until 10 June.

Our working hours will be 8.00am to 6.00pm (Monday-Friday) and 8.00am to 1.00pm Saturday if required.

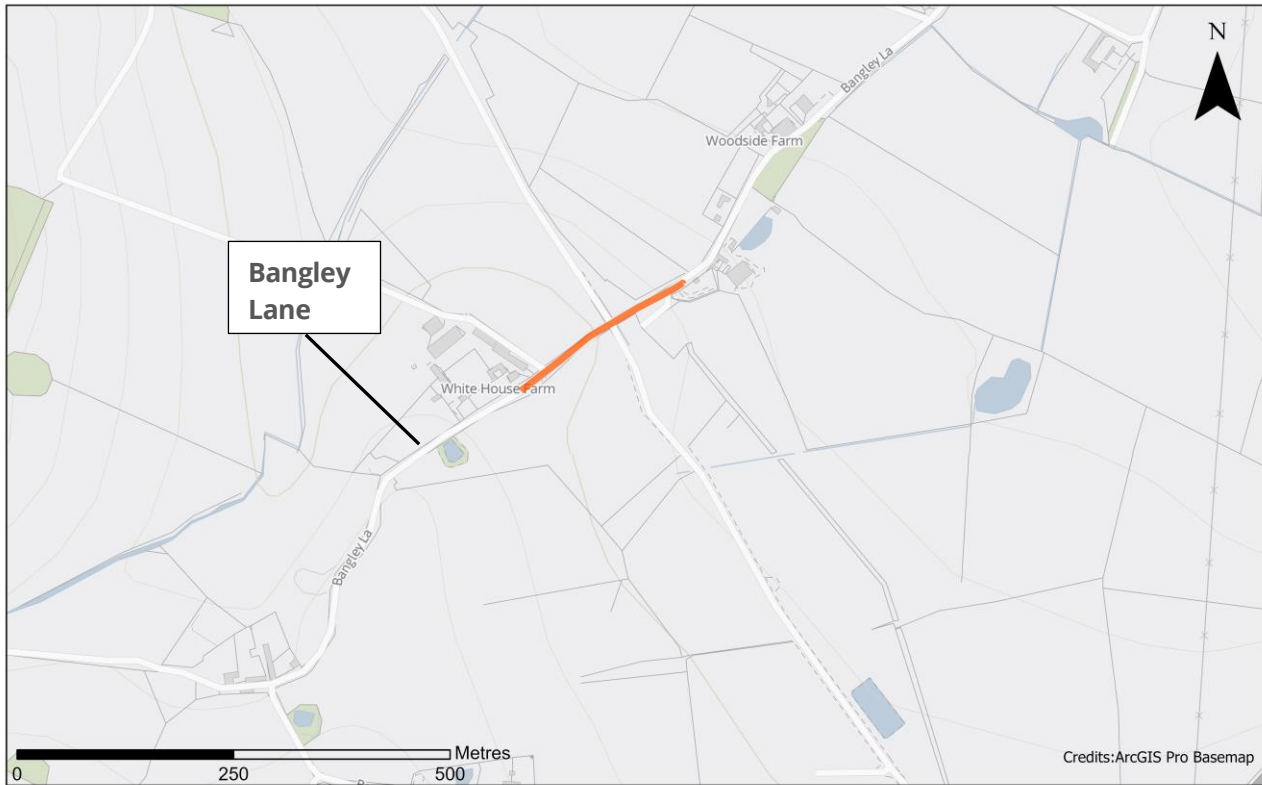
