
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

We will be moving excavated material along the line of route. To complete these works safely we will need to implement a reduction in the speed limit on Lichfield Road from 60mph to 40mph to allow large vehicles to turn safely in and out of our works area on Lichfield Road.

When the work will take place

We will install a reduction in the speed limit on Lichfield Road from 60mph to 40mph from 24 April to 20 December 2024 (24 hours, seven days per week).
