High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

We will be using the plant crossing that was installed on Flats Lane to start moving material along the line of route. The plant crossing point will be in use for six weeks.

When the work will take place

To complete our works on Flats Lane we will require temporary traffic management as follows:

• 13 May to 17 June 2024 between 8.00am to 6.00pm Monday to Friday and 8.00am to 1.00pm Saturday.
