



Notice of temporary traffic management on A51, Tamworth Road, Whittington

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be improving the site access to Whittington Heath Golf Club close to A51 Tamworth Road.

We will be required to create a safe working area, to allow our vehicles to access Whittington Heath Golf Club and to maintain the safety of road users, equestrian and pedestrians, we will require temporary two-way temporary traffic lights.

When the work will take place

We will have temporary two-way traffic lights from **29 April** until **30 April** between **8am** to **6pm**.

There will be temporary traffic lights on 29 April until 30 April 2023 between 8am to 6pm.
