#### What are we doing?

In mid-May there will be 4-way traffic lights traffic lights at the crossroads of Steeple Claydon Road, Twyford Road, West Street and Gawcott Road. This work will involve ditch clearance on West Street and surveys to the existing drainage.

To carry out these surveys safely and effectively, there will be traffic management in the form of a lane closure with 4-way traffic lights which will change to 2-way traffic lights mid-week. This is for reasons of safety, as operatives will be working on and around parts of the carriageway.

These surveys were due to take place within the previous traffic management from 5 February until 5 May however due to specialist engineering works having to take place on the gas main the survey works had to be delayed.

#### When will these works take place?

The westbound carriageway of West Street will be closed from Monday 13 May until Friday 17 May 2024 between the hours of 9:00am-3:00pm and will be controlled by 4-way traffic management.

These dates may be subject to change due to circumstances outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes or updates.

#### **Duration of works**

A section of West Street will be under traffic management from;

Monday 13 May until Friday 17 May 2024 between 9:00am and 3:00pm to avoid peak travel times;

> 4-way traffic lights at the crossroads of Steeple Claydon Road, Twyford Road, West Street and Gawcott Road.

Works will be carried out between 9:00am and 3:00pm however some additional evening or weekend working may be required when necessary.

#### What to expect

Lane closure on West Street managed by 4-way traffic lights.

Varied activities with both quiet and busier periods.

#### What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.


