What are we doing?

From late April, our continuing works on the HS2 line will focus on the area around the Waddesdon Greenway crossing, which intersects with the new railway route.

Next to the Waddesdon Greenway crossing with the HS2 worksite, we have identified an area of historical contamination. As a result, we must carry out remediation works at the affected area. Some of this work was undertaken in March during which further historical contamination was discovered. Due to the proximity with the Waddesdon Greenway, we must again close the crossing to ensure our teams can work in a safe working zone and to ensure the safety of the public.

The Greenway crossing will remain open to the public during daytime hours but will close overnight for five nights to allow this work to take place. There will be no access across the HS2 worksite via the Waddesdon Greenway during this time. These works have been coordinated to occur overnight to ensure minimum disruption to the public.

When will these works take place?

 Monday 29 April to Saturday 4 May -Footpath closure overnight from 8pm to 5am

These dates may change due to conditions outside of our control. Please refer to the HS2 website regularly to check for any changes and updates.

Duration of works

Overnight footpath closures from Monday 29 April to Saturday 4 May

Footpath will be closed between 8pm-5am.

What to expect

No access along Waddesdon Greenway across the HS2 work site.

Varied activities including use of machinery and work lighting with quieter and busier periods.

What we will do

Minimise disruption as much as possible for the community.

Provide updates for communities and maintain regular contact points for the duration of the work.

Where will these works take place?

The map below shows the section of the Waddesdon Greenway crossing in red that will be closed between the hours of 8pm and 5am from Monday 29 April to Saturday 4 May. The Waddesdon Greenway will reopen from 5am on Saturday 4 May.

Due to the location of the crossing point, we are unfortunately unable to provide an alternative route during the closures. We will however endeavour to work quickly to reopen the Waddesdon Greenway to the public as soon as possible.
