High Speed Two (HS2) is the new high speed railway for Britain.

We are expecting the Tunnel Boring Machines (TBMs) tunnelling from West Ruislip to Greenford to pass through your local area in summer 2024. We will let you know in advance of the TBMs passing.

Installation of monitoring equipment from 3 to 10 May

Between 3 and 10 May 2024, we will install monitoring equipment on a rail bridge near Allington Close, Greenford. We will use handheld power tools to install the monitoring equipment on the rail bridge.

Our surveying team will visit for short periods of time to monitor the bridge before and during construction of the HS2 tunnels. During some phases of construction these visits may be daily. The surveys will be ongoing for 12 months after the tunnelling in your local area.

The map below shows the approximate location for the monitoring equipment.
