What are we doing?

In April 2024 there will be a closure on Station Road North, to remove concrete barriers. The barriers need to be removed to allow the construction of a ramp to access Buckinghamshire Railway Centre.

To carry out these works safely and effectively we will need to close a section of Station Road North with signed diversions. This is for reasons of safety, as our operatives will be working on and around the carriageway.

When will these works take place?

A section of Station Road North will be closed from Wednesday 24 April at 8:30pm and will re-open on Thursday 25 April at 5:30am.

These dates may be subject to change due to circumstances outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes or updates.

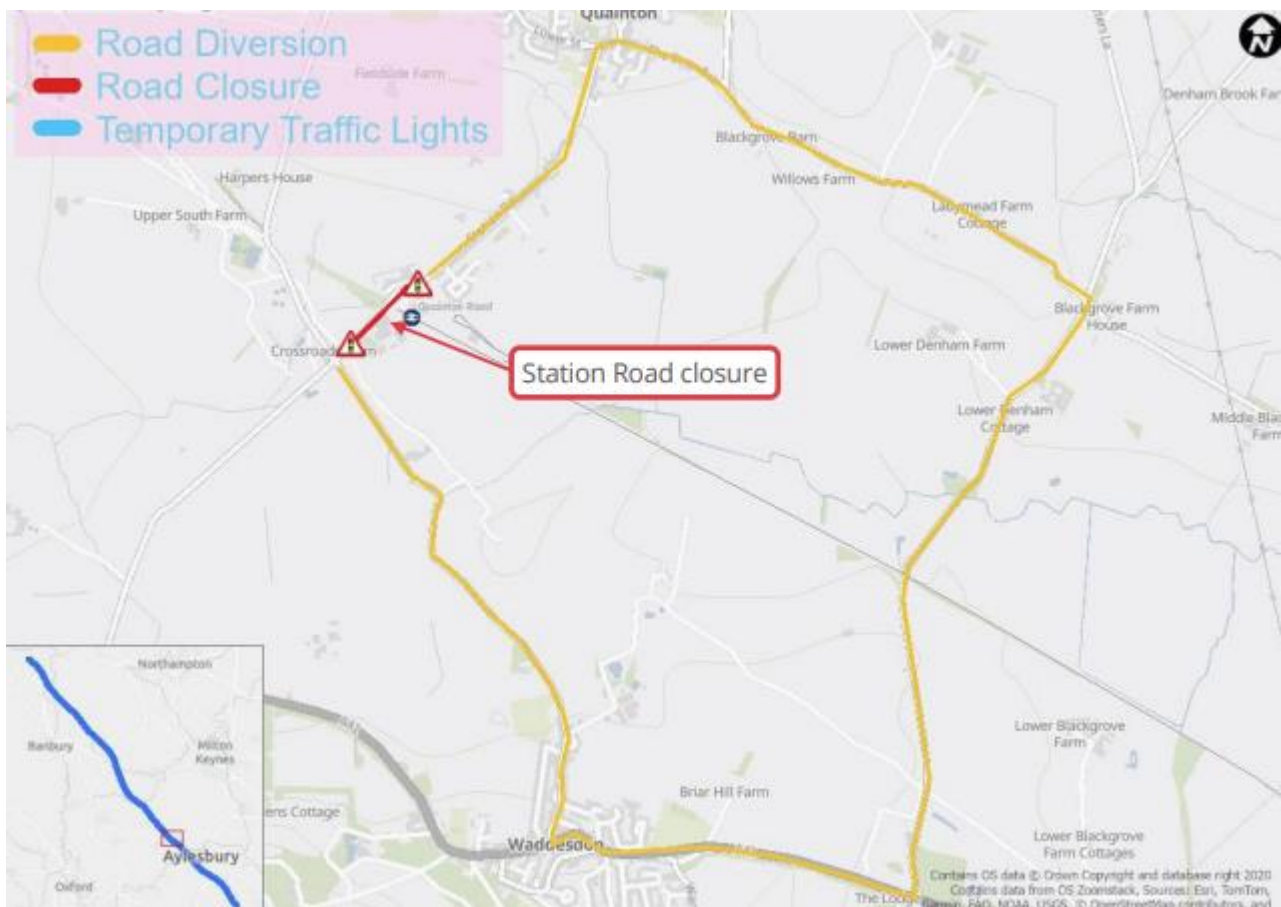
