

# Notice of road closure, Whielden Lane, Amersham

High Speed Two (HS2) is the new high speed railway for Britain. This notice is to inform you of a temporary road closure on Whielden Lane, Amersham, Buckinghamshire.

## How will these works affect me?


Part of Whielden Lane will be closed from the A404 to the entrance of our Amersham shaft site, on Saturday 20 April 2024 during the day between 8am and 4pm. We will provide signage for a diversion route from the A404 via the A413, Gore Hill and The Broadway.

## What will we be doing?

We will undertake site maintenance works including:

- Site boundary hoarding and signage cleaning
- Grass strimming and clearance of verges and footpaths
- Drain inspections

To do this safely the road will be temporarily closed until these works are completed. See map below:
