High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

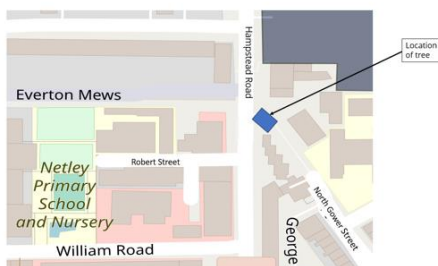
## Hampstead Road emergency tree pruning works

During the recent high winds in the area, a branch on a tree on Hampstead Road by George Mews was damaged causing a health and safety concern. To make this tree safe, we will be carrying out the following works:

- Tree pruning
- Removal of hanging broken branch
- Removal of dead wood

These works will take place from week commencing 20<sup>th</sup> May 2024 for approximately 5 days during core working hours (8am to 6pm Monday to Friday).

We expect these works to generate noise particularly during the use of a chainsaw, however, during this time we will ensure that every effort is made to keep unnecessary noise to a minimum. Please also note that a pedestrian walkway will be maintained at all times.

We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable, however every effort is made to minimise any unnecessary noise. Please note that changes to the programme may occur and if these changes are likely to cause any disturbance, we will write to you again.

- From week commencing 20<sup>th</sup> May 2024 for approximately 5 days 8am and 6pm
- Start-up and close-down activities up to one hour before and up to one hour after working hours above
