High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be working along Gilson Road to undertake important repair work within the site entrance.

### When the work will take place

To ensure the safety of our workforce and road users, we will be using stop & go signals on Gilson Road on 11 June 2024.
