High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

We will be undertaking utilities surveys on Church Lane and A4091 Northbound that will require a full one-week overnight closure. This will be to establish what utilities are beneath the road and what condition they are in ahead of future construction works. To complete these works safely we will need to implement a safe working area that will require the full closure of Church Lane and A4091 Northbound.

When the work will take place

We will install full overnight closures on Church Lane and A4091Northbound to complete utilities surveys as follows:

- **Church Lane** and **A4091**, full overnight closure **17**, **18**, **19 June** our working hours will be 8.00pm to 6.00am.
- **Church Lane** full overnight closure **20,21 June** our working hours will be 8.00pm to 6.00am.

These works have been planned overnight to minimise the impact on road users.


