High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Our works

We recently created a temporary diversion on the A453 Sutton Road, to allow for future construction works, and to enable the A453 Sutton Road to pass over the new railway.

To enable us to complete these works we will require an overnight closure of A453 Sutton Road and Drayton Lane to install permanent traffic signage.

When the work will take place

We will have an overnight full closure on A453 Sutton Road and Drayton Lane on **14 June** from 8pm until 6am. There will be a fully signed diversion in place during this time.

These works have been scheduled overnight to reduce the impact on the community. Emergency services will have access through our works.

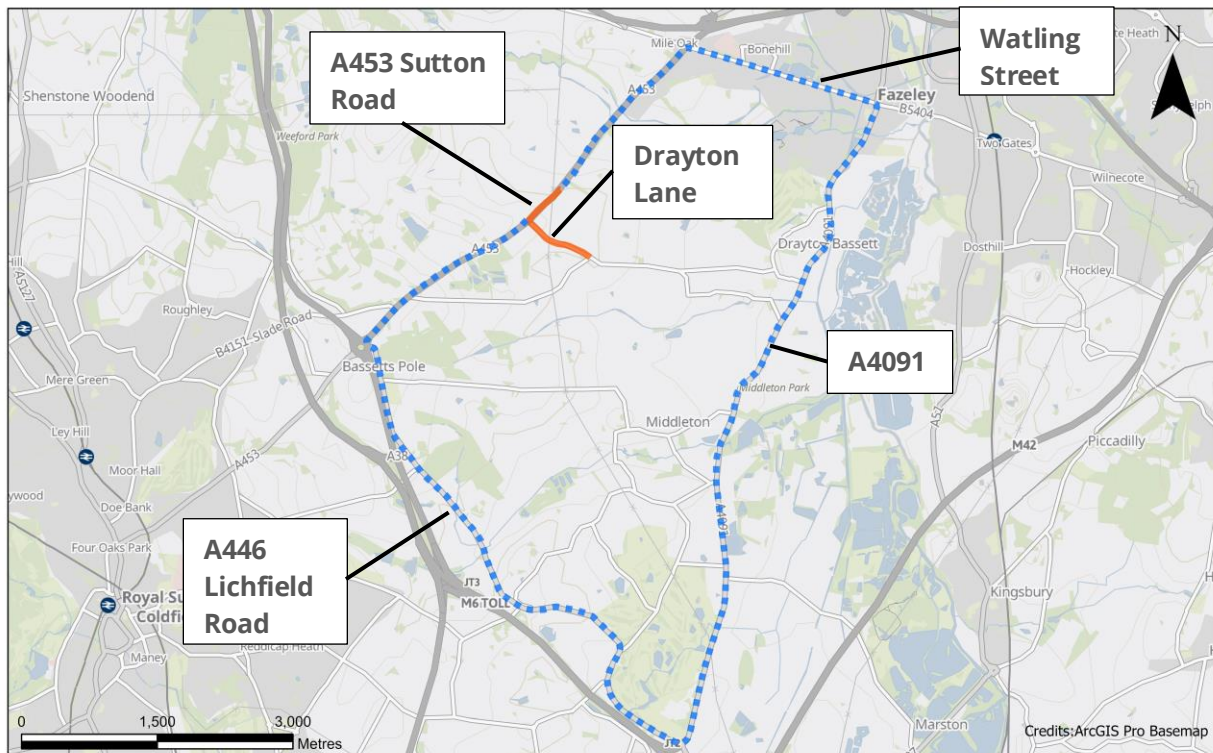
