Overnight Lawley Middleway Lane and Footpath Closures

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Overnight lane and footpath closures

In preparation for our plan to push a bridge over Lawley Middleway to carry the HS2 railway over the dual carriageway, we need to implement a series of single lane and footpath closures.

From Monday 27 May to Sunday 16 June 2024, will first close a single lane and the footpath on Lawley Middleway northbound. Once these works are complete, we will reopen the lane and footpath and then close a single lane and the footpath on Lawley Middleway southbound.

During this time, we will keep a single lane open for traffic and direct pedestrians to the footpath on the other side of Lawley Middleway. Lawley Middleway northbound will remain fully open.

Our plan

The Lawley Middleway bridge is part of the Curzon Street Station approach, the section of track that will lead trains in and out of Curzon Street station.

We are currently building the bridge 'offline' in our site next to Lawley Middleway, meaning we can minimise the number and length of closures required.

When we push the bridge over Lawley Middleway we will need to close the whole road overnight. During this time a diversion will be in place and access will be maintained to Landor Street. We will provide further details of the closure at least two weeks before.

Overnight closures lane and footpath closures on Lawley Middleway in both directions:

Monday 27 May -Sunday 16 June 2024, 8pm to 5.30am

One lane on Lawley Middleway will remain open for traffic

Pedestrians will be directed to the footpath on the opposite side of the road



Location of the single lane closures


The location of the lane closures on Lawley Middleway northbound (left) and southbound (right) can be seen below.
