



# Notice of overnight installation of ground monitoring equipment

High Speed Two (HS2) is the new high speed railway for Britain.

## Installation of monitoring equipment

On **24 and 25 May 2024**, we are planning to install ground monitoring equipment under the bridge on Oldfield Lane North next to Greenford Station between 10pm and 5am.

The image below is an example of the type of monitoring equipment, or prisms, that will be used.



The ground monitoring equipment will remain in place for a minimum of one year while we build the HS2 London tunnels. Our surveying team will undertake monitoring from tripods set up by the roadside on a weekly basis, increasing to daily during tunnelling in the area, and will check on the equipment to ensure it is clean and operating well.

The monitoring equipment will be removed when our works are completed in your local area. Following its removal, we will carry out repairs to make good the area where the monitoring equipment was located.

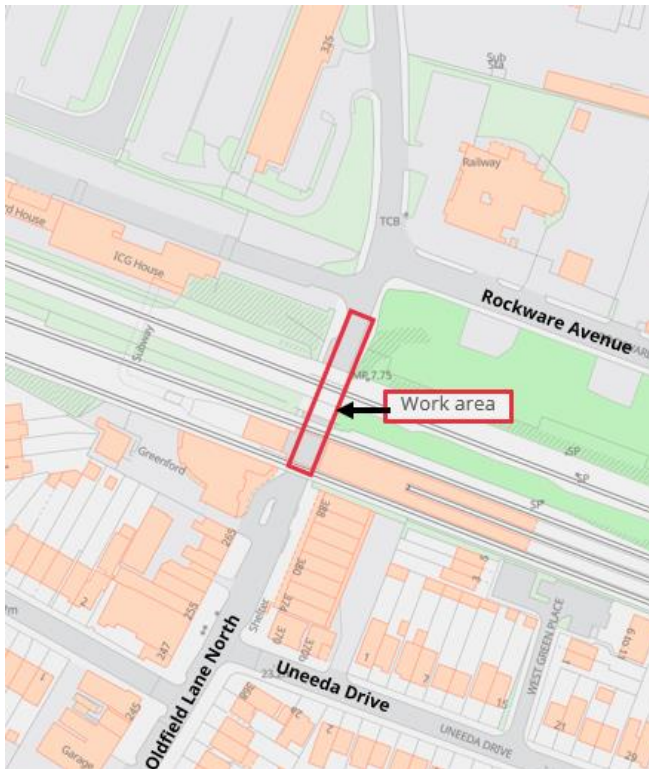
