High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be transporting oversized steel beams to our Coleshill Viaduct south site. For the safety of our workforce and road users this requires a road closure.

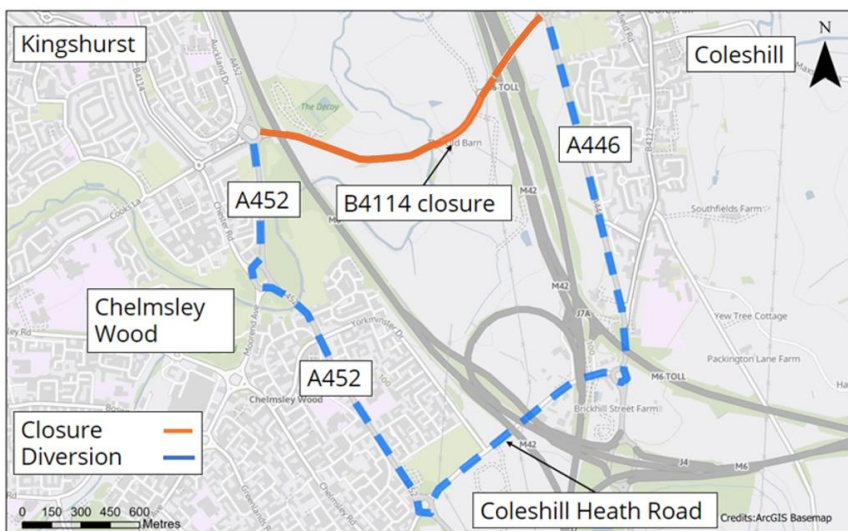
Warwickshire County Council will also be using this road closure for the maintenance of the road and drainage systems.

When the work will take place

The closure will be in place from 8.30pm on Tuesday 4 June to 5am on Wednesday 5 June and again on Thursday 6 June from 8.30pm to 5am on Friday 7 June.

Duration of works

Road closure of the B4114, Birmingham Road

Tuesday 4 June and Thursday 6 June, 8:30pm to 5am, on both nights

Our workforce may be on-site up to one hour before and after to set up and secure our equipment

Transportation of steel beams to our Coleshill Viaduct South site, resulting in the closure of the B4114

Low-level of noise from our machinery
