Vegetation clearance and maintenance

On **Sunday 16 June 2024**, we will trim vegetation next to the railway tracks behind Kildun Court and Wells House Road.

These works will take place between 1am and 4am when trains are not using the railway track.

If we are unable to complete these works on 16 June, our team will visit the area next to the railway tracks on 23 June to complete the works.

The team will visit every six to eight weeks to keep the vegetation trimmed. This is to ensure that the visibility for monitoring equipment is clear at all times.
