High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### The work we will be doing

To prepare for our continued construction in the area, BBV will be undertaking utility works along Attleboro Lane. The works include laying ducts in the footpath and across the road.

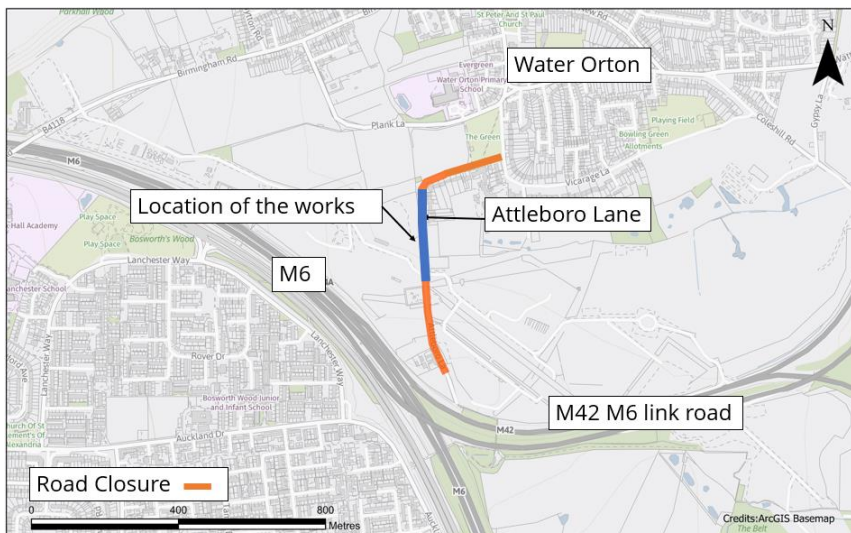
### When the work will take place

To complete the works safely, we will install traffic management from 24 June to 23 August 2024. The traffic management will be in place during our weekday working hours which will be from 8am to 6pm.

Access to properties will be maintained throughout the works.
