High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

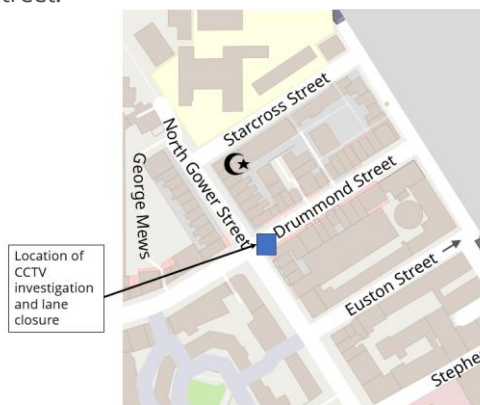
CCTV Investigative Gas Works

As part of our essential programme of utilities works, we will be carrying out CCTV investigative works on Drummond Street by the junction of North Gower Street which will determine the future programme of works for the new gas main connection in this area.

These works will commence on **Monday 20 May 2024 and is anticipated to be completed by Friday 31 May 2024**. Working hours will be Monday to Friday, 8am to 5pm. Please note that works will not take place on the weekend, and traffic management will remain in place. We will contact you again to let you know the outcome of the CCTV investigation and inform you of the longer-term programme for gas works on Drummond Street.

Traffic Management

Throughout the duration of these works, there will be a lane closure on Drummond Street. There will also be two parking bays and one loading bay suspension at the top of Drummond Street by the junction of North Gower Street.



We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable, however every effort is made to minimise any unnecessary noise. Please note that changes to the programme may occur and if these changes are likely to cause any disturbance, we will write to you again.
