



# Notice of installation of road markings on Eversholt Street

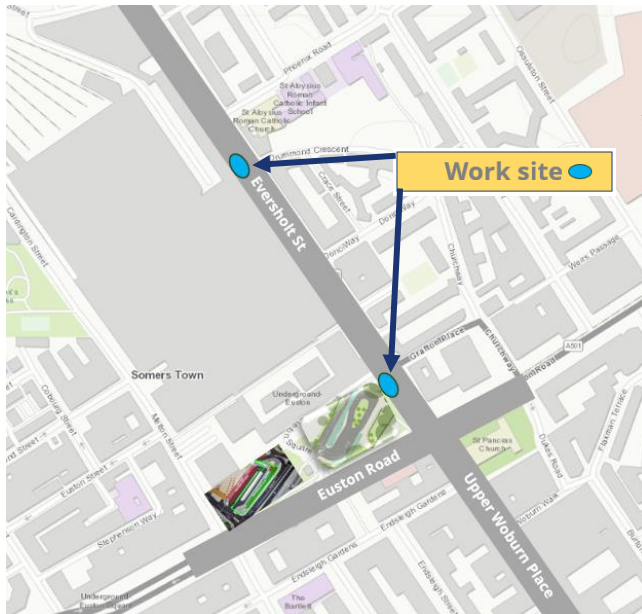

High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

## Installation of road markings on Eversholt Street

From **22 until 24 May 2024 between 9pm and 5am (daily)**, we will undertake road markings at two locations on Eversholt Street. This work is part of the final phase of the new Euston Taxi Rank and due to other works on Eversholt Street could not be installed before the new rank opened. Vehicle access will be maintained on Eversholt Street, and we will restrict the lanes to facilitate the work sites.

We expect these works to generate noise for approximately one hour on each night when we remove the existing road markings.



We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable, however every effort is made to minimise any unnecessary noise. We always try to complete works as quickly as possible, **but please be aware the timeframe given above is a guide and that poor weather may mean the timings can change.** If these changes are likely to cause any disturbance, we will write to you again.

- 22 until 24 May 2024 between 9pm and 5am
- Start-up and close-down activities up to one hour before and up to one hour after working hours above

- Pedestrian and vehicle access will be maintained

- Keep all sites safe and secure
